
Subject: Promotion of Patwaries as Girdawar Qanoongos.

**ORDER NO :** 695 DIVK of 2016

**DATED :** 07- 12 - 2016

Whereas; the Hon'ble High Court vide order dated 30/05/2016 passed in clubbed Writ Petition Nos.2275/2015 CW SWP No.1762/2015 and 2235/2015, the verbatim of which reads as under:-

- a. The official respondents are directed to undertake the exercise to find out as to which, amongst the selected/appointed candidates, qualified their Patwar Training Course Examination within the probation period and thereafter determine their seniority in accordance with the merit secured by them in the selection/merit list prepared by the Service Selection Board at the time of their initial selection. Those Patwaries, who qualified the Patwar Training Course Examination beyond the probation period shall rank junior to those Patwaries who qualified the said examination within the probation period though they ranked below them in the initial Selection List prepared by the Service Selection Board.
- b. After framing of fresh seniority list, in view of the aforesaid direction, the concerned official respondents shall amend the promotion orders, already made, and grant promotion to the Patwaries on the basis of the seniority list so framed. The concerned official respondents shall also, while amending/framing the seniority list, ensure that the Government order No.Rev(NG)-52 of 2015 dated 09<sup>th</sup> March, 2015 is complied with;
- c. The concerned official respondents to initiate and conclude the aforesaid exercise within eight weeks from the date copy of this order is received by them.
- d. Till the aforesaid exercise is completed, the promotion orders made, shall remain undisturbed. Interim directions in all these petitions, shall stand vacated."

Whereas; in compliance to the aforesaid directions of the Hon'ble High Court, the Deputy Commissioners were directed to frame the seniority list of Patwaries borne on their respective district cadres;

Whereas; the reframed seniority list of District Kupwara and Baramulla was received by this office and the same placed before Departmental Promotion Committee on 31/10/2016;

Whereas; after the deliberations the Departmental Promotion Committee cleared the eligible Patwaries as per annexure "A" to this order and recommended to their promotional benefits as Girdawar Qanoongos w. e. f. 06/10/2015 "Notionally" and "31/10/2016 "Regularly": -

Now therefore in view of the above, sanction is hereby accorded to the promotion of the Patwaries as per annexure "A" to this order as Girdawar Qanoongos in the pay band of 9300-34800 with Grade Pay of Rs 4200/- Notionally w.e.f 06-10-2015 and regularly w.e.f. 31-10-2016. The promotees shall join in the office of Divisional Commissioner Kashmir for further postings.

This order shall be without prejudice to the outcome of court case, if any, pending in the Hon'ble Court.
