Whereas, one Syed Abid Hussain Indrabi, L/A Naib Tehsildar has represented with an application to this office on 27-08-2014 stating therein that he was appointed as a Patwari in the year 1987 vide Deputy Commissioner, Anantnag's Order No.1429/SQ dated 22-01-1987 and joined on the same date; and

Whereas, the said official has further submitted that his date of appointment as Patwari has been shown as 08-04-1987 instead of 22-01-1987 in the seniority list of Girdawars and in support of his claim the official has annexed a Xerox copy of his Service Book; and

Whereas, this office vide letter No.DivCom/11-S-PTW/Sgr/Estt dated 20-11-2014 has taken up the matter with Deputy Commissioner, Anantnag for furnishing of certified copy of 1<sup>st</sup> appointment order of the official; and


Whereas, the Deputy Commissioner, Anantnag vide letter No.DCA/Accts/14-15/847 dated 22-11-2014 has intimated that Tehsildar Anantnag vide his letter No.356/AC/274 dated 22-11-2014 reported that the 1<sup>st</sup> appointment order copy of the official is not available however, the official has drawn salary as Patwari w. e. f. 22-01-1987 to 31-08-1990; and

Whereas, this office vide letter No.DivCom/11-S-PTW-Sgr/Estt dated 29-11-2014 has requested the Deputy Commissioner, Anantnag for furnishing of the certified copies of the A. Roll on which the detail of salaries of the official is recorded; and

Whereas, the Deputy Commissioner, Anantnag vide letter No.DCA/Accts/14-15/948 dated 21-01-2015 has furnished A. Roll on which the salaries of the official was recorded at S. No.51 w. e. f. 01/1987; and

Whereas, the said official has again represented this office with an application on 15-12-2015 with the same plea;

Now, therefore in view of the above and before considering the plea of the official, it is hereby notified for inviting all concerned through the medium of this notification that the first appointment of Syed Abid Indrabi Patwari is to be read as 22-01-1987 instead of 08-04-1987. Any objection, in this regard should reach to this office within 15 days and after stipulated period no objection whatsoever shall be entertained.
