

Now therefore the updated seniority list of Sections Officers of Divisional Cadre Kashmir of Revenue Department as on 01-04-2022 is hereby issued forming Annexure "A" to this order.



The review petitions, if any, containing facts that have not been considered as have come to right now and which have a material bearing on the issue of determination of seniority, should reach this office within a period of one month from the date of issue of this order failing which the seniority list shall be deemed final.



The Seniority list shall however be subject to final outcome of the pending court case(s), if any.

The D.O.B recorded/indicated against the official(s) in the seniority list shall not be taken as authenticated, and, shall be subject to further verification from the service book/ matriculation certificate/ other relevant record as prescribed under norms.


