Whereas, two Saddar Mohasibs figuring at S. No.02 and 03 of the said seniority list have superannuated from Govt. Service; and


Whereas; the following Mohasibs were promoted to the next higher level after the issuance of final seniority of Saddar Mohasibs dated: 10-08-2020;
