Whereas; this office vide notification dated 20-12-2016 issued under endorsement No.DivCom/45-PTW/Estt dated 02-01-2017 invited objections from the officials (Girdawars) regarding their placement, date of birth etc. in their updated final seniority list; and

Whereas; objections were received from the officials and were disposed off as per merit; and

Whereas; updated final seniority list as stood on 31-12-2016 was issued by this office vide Order No.868 DIVCOM dated 27-02-2017 under endorsement No.DivCom/45-PTW/Estt dated 27-02-2017; and

Whereas; one Ghulam Mohi-ud-Din Bhat, Girdawar Qanoongo at present I/C Naib Tehsildar Khurhama, Kupwara represented this office with an application on 06-03-2017 stating therein that his name has been deleted from the seniority list of Girdawar Qanoongs and he was figuring at S. No.106 in the final seniority list of Girdawar Qanoongs issued by the office of Divisional Commissioner, Kashmir in the year 2014. Similarly another official namely Shri Ghulam Ahmad Mir figuring in the updated final seniority list of Girdawar Qanoongs at S. No.17 represented with the plea that he has been elevated as Naib Tehsildar vide Financial Commissioner (Revenue), J&K's Order No.FC(A)34 of 2015 dated 10-02-2015; and


Whereas; from the perusal of records the official namely Ghulam Mohi-ud-Din Bhat was figuring at S. No.106 in the final seniority list of Girdawars Qanoongs issued by this office in the year 2014 and due to clerical error his name got deleted in the latest final seniority list of Girdawar Qanoongs. Similarly designation of one Ghulam Ahmad Mir figuring at S. No.17 has been mentioned as Girdawar while as he is a confirmed Naib Tehsildar as per the order referred above, issued by the Financial Commissioner (Revenue), J&K thus the claim of the officials was found as genuine; and

Whereas; the name of Shri Ghulam Mohi-ud-Din Bhat, Girdawar Qanoongo is to be incorporated at Serial No.60 in the final updated seniority list of Girdawar Qanoongs and also the name of Shri Ghulam Ahmad Mir figuring at S. No.17 is to be deleted from the updated final seniority list ;

Now, therefore in view of the above and before considering the request of Shri Ghulam Mohi-ud-Din Bhat for inclusion at S. No.60 and exclusion of Shri Ghulam Ahmad Mir figuring at S. No.17 in the final seniority list, objections, if any, are invited from the officials concerned regarding their placement/exclusion in the seniority list. Any official having objections, if any with regard to the subject should file the same before this office within 15-days from the date of issuance of this notification. After the expiry of stipulated period, no objection shall be entertained.
