Whereas, Deputy Commissioner, Shopian in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Rules, 1997 has also issued "No Objection Certificate" under endorsement No: DCS/SQ/22-23/532 dated 03.06.2022 and No. DCS/SQ/22-23/890-91 dated 26.07.2022; and

Now, therefore, in pursuance of the powers vested upon me under Section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act, 1997, sanction is hereby accorded to the alienation of land measuring 09 kanal 05 marlas falling under Survey No. 340 (2M), 585 (1K-4M), 589 (6K-16M) and 615 (1K-3M) situated in estate Chowdrigund, Tehsil & District Shopian BY S/Smt. (1) Tosha D/o Mashar Nath and (2) Vijay Kumari D/o Late Amar Chand Bhat R's/o Chowdrigund, Tehsil & District Shopian A/P Anand Nagar, Bohri near Atma Ram Ashram, Jammu IN FAVOUR OF Mst. Haleema Parveen Wd/o Nazir Ahmad Shah R/o Chowdrigund, Tehsil & District Shopian, subject to the following conditions: -

- KASHMIR
- a) That the applicant(s) is/are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property under proposed alienation shall be calculated as per the stamp rate for the **calendar year 2023** of estate **Chowdrigund Tehsil & District Shopian** approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011 for the Calendar year **2023**.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Shopian (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.
