Subject: - Application of **Shri Veer Ji Matoo S/o Lt. Shamboo Nath Matoo R/o Malpora, Habba Kadal, Srinagar A/P Migrant Bohri, Talab Tilloo, Jammu** for permission to alienate migrant immovable property in accordance with the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997.

Whereas, Deputy Commissioner, **Srinagar's** letter No: DCK/MLA/675/3097/MR dated 19.10.2019 has reported that the alienor(s) intend to alienate land measuring **01 marla 200 sfts falling under Survey No. 670-min situated of estate Habba Kadal, Tehsil South District Srinagar;** and

Whereas, Deputy Commissioner, **Srinagar** after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title, / and possession of the **land measuring 01 marla 200 sfts falling under Survey No. 670-min situated of estate Habba Kadal, Tehsil South District Srinagar** vide his above referred letters, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997;

Whereas, the Deputy Commissioner **Srinagar** in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Rules, 1997 has also issued "No Objection Certificate" under endorsement No. **DCK/MLA/675/ 3097/MR dated 19.10.2019;** and

Whereas, to rule out the possibility of distress sale, the alienor(s) was heard on video call who authenticated the veracity of the documents executed by him and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

Now, therefore in pursuance of the powers vested upon me under Section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act, 1997, sanction is hereby accorded to the alienation **land measuring 01 marla 200 sfts falling under Survey No. 670-min situated of estate Habba Kadal, Tehsil South District Srinagar BY Shri Veer Ji Matoo S/o Lt. Shamboo Nath Matoo R/o Malpora, Habba Kadal, Srinagar A/P Migrant Bohri, Talab Tilloo, Jammu IN FAVOUR OF Shagufta Ahad D/o Abdul Ahad Bhat R/o Malpora, Habba Kadal, Srinagar,** subject to the following conditions: -

- a) That the applicant(s) are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property (land) under proposed alienation shall be calculated as per the stamp rate for the **calendar year 2023** of estate **Habba Kadal**, Tehsil South District Srinagar as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011. Besides, an amount of **Rs. 10,55,917/- (Rupees ten lacs fifty-five thousand nine hundred and seventeen)**, value of the structure as assessed by the Superintending Engineer, PWD (R&B) Circular Road Project, Srinagar, shall added to the value of the property in question.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997 and rules made there under, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act / Rules there under for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate Srinagar (Custodian of the Migrant Immovable Property) handover the possession thereof through prescribed procedure.
