Whereas, Deputy Commissioner, Kulgam's letter No: DCK/M/ACR/2019-20/65 dated 06.03.2020, No. DCK/M/ACR/2019-20/42 dated 30.07.2019, No. DCK/M/2018-19/108 dated 03.10.2018, DCK/M/ACR/2018-19/76 dated 30.07.2018, DCK/M/ACR/141 dated 01.06.2017 has reported that the alienor(s) intend to alienate land measuring 15 kanal 14 Marlas under Survey Nos. (Old) 175 (13 Marlas), 176 (13 Kanals 03 Marlas), 180 (13 Marlas), 181 (1 Kanal 05 Marlas), (New) situated in estate Shirpora, Tehsil Frisal, District Kulgam; and

Whereas, Deputy Commissioner, Kulgam after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title, / and possession of the land measuring 15 kanal 14 Marlas under Survey Nos. (Old) 175 (13 Marlas), 176 (13 Kanals 03 Marlas), 180 (13 Marlas), 181 (1 Kanal 05 Marlas), (New) situated in estate Shirpora, Tehsil Frisal, District Kulgam vide his above referred letters, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997; and


Whereas, Deputy Commissioner, Kulgam in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Rules, 1997 has also issued "No Objection Certificate" under endorsement No. DCK/M/ACR/2019-20/65 dated 06.03.2020, No. DCK/M/ACR/2019-20/42 dated 30.07.2019, No. DCK/M/2018-19/108 dated 03.10.2018, DCK/M/ACR/2018-19/76 dated 30.07.2018, DCK/M/ACR/141 dated 01.06.2017; and

Whereas, to rule out the possibility of distress sale, the alienor(s) were heard on video call who authenticated the veracity of the documents executed by them and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

Now, therefore, in pursuance of the powers vested upon me under Section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act, 1997, sanction is hereby accorded to the alienation of land measuring 15 kanal 14 Marlas under Survey Nos. (Old) 175 (13 Marlas), 176 (13 Kanals 03 Marlas), 180 (13 Marlas), 181 (1 Kanal 05 Marlas), (New) situated in estate Shirpora, Tehsil Frisal, District Kulgam BY S/Shri (1) Ramesh Chander (Son) (2) Jawahar Lal (Son) (3) Manoj Kumar (Son) (4) Uma Shori Wd/o Shambu Nath Raina (5) Ashok Kumar S/o Prithvi Nath (6) Sanjay Kumar (Son) (7) Anil Kumar (Son) (8) Rani Wd/o Kashi Nath (9) Dilip Kumar (Son) (10) Kuldeep Kumar (Son) (11) Sunil Kumar (Son) (12) Vinod Kumar (Son) (13) Rani Wd/o Soom Nath Raina. All R's/o Shirpora, Tehsil Frisal, District Kulgam. A/P Purkhoo Camp, Jammu IN FAVOUR OF **Muzaffar Ahmad Shah S/o Mohammad Abraham Shah R/o Panzgam, District Pulwama, and Abdul Rub Shah S/o Mohammad Yaqoob Shah R/o Bijbehara, District Anantnag** subject to the following conditions: -

- a) That the applicant(s) is/are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property under proposed alienation shall be calculated as per stamp rate for the calendar year 2023 of estate Shirpora, Tehsil Frisal, District Kulgam **as approved** by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Kulgam (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.
