Whereas, Deputy Commissioner, Budgam's letter No: DCB/SQ/19/F=73/1352 dated 21.01.2019, No. DCB/SQ/19/73(Val)/2251 dated 04.05.2019, No. DCB/SQ/2023-24/F-73/205 dated 13.04.2023 and No. DCB/SQ/2023-24/F-73/2119 dated 20.07.2023 has reported that the alienor(s) intend to alienate land measuring 02 kanals covered under Survey No. 116-min situated in estate Doyen, Tehsil Chadoora, District Budgam; and

Whereas, Deputy Commissioner, Budgam after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title, / and possession of the land measuring 02 kanals covered under Survey No. 116-min situated in estate Doyen, Tehsil Chadoora, District Budgam vide his above referred letters, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997; and

Whereas, Deputy Commissioner, Budgam in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Rules, 1997 has also issued "No Objection Certificate" under endorsement No.: DCB/SQ/19/F=73/ 1352 dated 21.01.2019; and

Now, therefore, in pursuance of the powers vested upon me under Section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act. 1997, sanction is hereby accorded to the alienation/transfer of lease hold rights of land measuring 02 kanals covered under Survey No. 116-min situated in estate Doyen, Tehsil Chadoora, District Budgam BY S/Sh. Vijay Kumar @ Jai Krishan Koul S/o Late Sh. Pushkar Nath Pandit R/o Chadoora, Tehsil Chadoora, District Budgam A/P Migrant at H. No. 51, Indira Colony Opposite Peerbaba, Talab Tilloo, Jammu IN FAVOUR OF (1) Mohammad Amin Bhat S/o Haji Ghulam Mohammad Bhat and (2) Mst. Hameeda W/o Bashir Ahmad Bhat R's/o Darbugh, Tehsil Chadoora, District Budgam, subject to the following conditions: -

- a) That the applicant(s) is/are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property (land) under proposed alienation shall be calculated as per the stamp rate for the **Calendar year 2023** of estate **Doyen, Tehsil Chadoora, District Budgam** as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Budgam (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.
