Subject: - Application of S/Sh. Sohan Lal Bindroo S/o Late Dina Nath Bindroo R/o Main Chowk, Baramulla A/P Migrant, H. No. 91, Wazir Lane Talab Tilloo, Jammu for permission to alienate migrant immovable property in accordance with the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997.

Whereas, Deputy Commissioner, Baramulla's letter No: DCB/SQ/Alie/1357 dated 14.06.2023 and No. DCB/SQ/2939-40 dated 28.08.2023 has reported that the alienor(s) intend to alienate land measuring 07 Sirsai 06 Sfts covered under Survey No. 4984/22 of estate Ushkara, Tehsil & District Baramulla; and

Whereas, Deputy Commissioner, Baramulla after due enquiry from the field functionaries in terms of prescribed procedure laid down under law/rules/guidelines in vogue has verified title, / and possession of land measuring 07 Sirsai 06 Sfts covered under Survey No. 4984/22 of estate Ushkara, Tehsil & District Baramulla vide his above referred letter, has recommended the case for grant of permission for alienation under the provisions of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997; and

Whereas, the Deputy Commissioner, Baramulla in terms of rule 3(b) of J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales), Rules, 1997 has also issued "No Objection Certificate" under endorsement No: DCB/SQ/Alie/1357 dated 14.06.2023; and

Com: Whereas, to rule out the possibility of distress sale, the alienor was heard on video call who authenticated the veracity of the documents executed by him and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

Now, therefore in pursuance of the powers vested upon me under Section 3 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act. 1997, sanction is hereby accorded to the alienation of land measuring 07 Sirsai 06 Sfts covered under Survey No. 4984/22 of estate Ushkara, Tehsil & District Baramulla BY S/Sh. Sohan Lal Bindroo S/o Late Dina Nath Bindroo R/o Main Chowk, Baramulla A/P Migrant, H. No. 91, Wazir Lane Talab Tilloo, Jammu IN FAVOUR OF (1) Ranbir Kour W/o Autar Singh R/o Nowpora, Jagir, District Baramulla, (2) Rifat Ara D/o Ali Mohammad Dar W/o Tariq Ahmad Bhat R/o Ladhoo, Khrew, Tehsil Pampore, District Pulwama and (3) Mushtaq Ahmad Yattoo S/o All Mohammad Yattoo R/o Yattoo Mohalla, Hazratbal, District Srinagar, subject to the following conditions: -

- a) That the applicant(s) is/are rightful owners/occupants of the property proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- b) That the value of the property (land) under proposed alienation shall be calculated as per the stamp rate for the **calendar year 2023** of estate **Ushkara**, Tehsil & District Baramulla as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011. Besides, an amount of **Rs. 1,96,126/- (Rupees one lac ninety-six thousand one hundred and twenty-six)**, value of the structure as assessed by the Executive Engineer, PWD (R&B), Baramulla, shall added to the value of the property in question.
- c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Baramulla (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.
