- b) That the value of the property under proposed alienation shall be calculated as per the stamp rate for the calendar year 2023 of estate Gadbugh, Tehsil Shahoora/Litter, District Pulwama as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- That any permission under this Act i.e., J&K Migrant Immovable c) Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate, Pulwama (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.
