Whereas, Deputy Commissioner, Srinagar's letter No: DCS/SQ/MLA/2951/MR/229 dated 26.10.2016, No. DCS/SQ/MLA/968/2951/MR dated 17.10.2019 and No. DMS/RD/2951-MR/56 dated 14.06.2023 has reported that the alienor(s) intend to alienate land measuring 01 kanal falling under Khasra No. 775 (09 marlas), 776 (10 marlas) and 779 (01 marla) situated at Rawalpora, Tehsil Chanapora/Natipora, District Srinagar; and

Whereas, to rule out the possibility of distress sale, the alienor(s) was heard on video call who authenticated the veracity of the documents executed by him and also intimated that the sale has not been made in distress/duress and consented to the grant of alienation permission in favour of the alienee(s).

- That the applicant(s) are rightful owners/occupants of the property a) proposed to be alienated and is free from all encumbrances and the title of the proposed alienor(s) is certified by the Tehsildar concerned under his seal and signatures.
- That the value of the property (land) under proposed alienation b) shall be calculated as per the stamp rate for the calendar year 2023 of Rawalpora, Tehsil Chanapora/Natipora, District Srinagar as approved by the Committee constituted under the J&K Preparation and revision of market value guideline rules 2011.
- That any permission under this Act i.e., J&K Migrant Immovable c) Property (Preservation, Protection & Restraint on Distress Sales), Act, 1997 and rules made there under, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act / Rules there under for the time being in force.
- d) That after completion of all registration formalities, the District Magistrate Srinagar (Custodian of the Migrant Immovable Property) handover the possession thereof through prescribed procedure.
