Whereas, Deputy Commissioner, Kulgam's letter No: DCK/M/2022-23/171 dated 16.09.2022 and No. DCK/M/2022-23/221 dated 15.11.2022 has reported that the alienor(s) intend to alienate land measuring 12 kanals 09 marias under Survey Nos. 08 (03K-04 M), 09 (06M), 10 (04M), 11 (05K-16M), 12 (01K-12M) and 14 (01K-07M) situated in estate Mirwani, Tehsii D.H. - c) That any permission under this Act i.e., J&K Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997 and rules made thereunder, shall not be construed as permission for conversion or change of land use which may otherwise be prohibited by any Act/Rules made thereunder for the time being in force.
- That after completion of all registration formalities, the District d) Magistrate, Kulgam (Custodian of the Migrant Immovable Property) shall handover the possession of the property to the alienee(s) thereof through prescribed procedure.
