Subject:-Minutes of the meeting held under the chairmanship of Hon'ble Minister for PWD(R&B), Floriculture and Gardens & Parks, J&K on 02-01-2016 in the meeting Hall of Divisional Commissioner, Kashmir to review stock position of essential commodities, Power Supply, Infrastructure development and status of implementations of Hon'ble CM's decisions/directions etc.

A meeting under the chairmanship of Hon'ble Minister for PWD(R&B), Floriculture and Gardens & Parks J&K was held on 02-01-2016 to discuss/ review stock position of essential commodities, Power Supply, Infrastructure development and status of implementations of Hon'ble CM's decisions/directions with the line Departments.

List of participants is enclosed as Annexure "A".


At the outset, Hon'ble Minister for PWD(R&B), Floriculture and Gardens & Parks J&K welcomed all the participants and got feedback about winter preparedness, stock position of essential commodities and power supply position in the valley. Besides, the Hon'ble Minister held a video conference with all Dy. Commissioners of Kashmir Division for the purpose and stressed the Divisional/District administration to gear up for providing uninterrupted essential services to people during anticipated snow fall in the valley.

The Hon'ble Minister was informed that 34 snow clearance machines are on standby mode in Srinagar city for clearing the snow from roads. A total of 113 snow clearance machines have been deployed for the entire valley with a provision of bringing 14 more such machines for ensuring the opening of roads within minimum possible time. The chair directed concerned officials to undertake snow clearance during night hours so that people will have clear roads for their movement in the morning. While reviewing the stock position of essential supplies, the chair was informed that there is a stock of essential commodities like rice, atta, sugar etc. for 36 days and LPG stock for 15 days available in the valley. The Hon'ble Minister directed CA&PD officials to maintain buffer stock to avoid any shortage during winters.


