Minutes of the meeting held under the chairmanship of Divisional Commissioner Kashmir on 19-09-2015 in connection with arrangements for Idd-ul-Azha.

A meeting under the chairmanship of Divisional Commissioner Kashmir was held on 19-09-2015 to stock and finalize the arrangements to be made for Idd-ul-Azha by various Govt departments including various security agencies.

List of participants in the meeting is appended as Annexure-A

At the outset, the Divisional Commissioner welcomed all the participants and the chair appreciated the efforts put in by the officers of different departments/organizations for making arrangement of Eid-ul Azha during last year and hoped that this year also the same would be managed with all zeal and vigour. It was impressed upon all the officers of civil/police to maintain seamless synergy and joint-manship to make the arrangements for upcoming festival in a proper way. Department-wise arrangements to be made were discussed and preparedness by different departments was assessed.


Divisional Commissioner, Kashmir informed the Traffic Department that there is traffic jamming in Srinagar city especially in Lal Chowk/Hari Singh Street etc due to street vendors on roadside and due to heavy rush of people/vehicles which needs to be given due attention and a proper traffic management plan be devised in order to avoid traffic jamming on the occasion.

After having threadbare discussions with all the concerned Heads of department/other representatives , the following decisions were taken:-

1. The J&K Muslim Wakf Board shall make necessary arrangements for Eid prayers at all shrines/mosques under their control where huge congregations are expected to take place. They will also ensure wide publicity of prayer timing of Eid-ul Azha through print / electronic media.

2. The Joint market checking teams comprising of CA & PD Deptt/Revenue/Police/SMC/Legal Metrology/Drug & Food Safety



Standards Deptt shall ensure market checking to check profiteering/black marketing of essential commodities by traders (wholesalers/retailers) and ensure availability of essential commodities like Mutton, Chicken, Vegetables, fruits, etc. However,

the following rates were decided in the meeting:-


- 3. Controller, Drug and Food Safety Organization was directed by the chair to ensure the standard quality of food items like Bakery products, snacks, soft drinks, spices and other food stuffs. (Action by: Controller, Drug and Food Safety)
- 4. The PDD Deptt. should ensure uninterrupted power supply on the eve of Eid-Ul-Azha at all shrines/mosques where huge congregations are expected including Hazratbal shrine.

 (Action by:CE, PDD)
- 5. The PHE Deptt. shall make adequate measures for providing of water supply on the Eid-ul-Azha. They will also ensure availability of Water through tankers at the places where large congregational payers are expected in the areas having water scarcity.

 (Action by:CE, PHE Deptt)
- 6. The CA & PD Deptt. Shall make all possible arrangements for availability of ration i.e Rice, Atta, Sugar, K-oil and LPG cylinders in buffer stock on the occasion as per notified rates and of standard quality.

(Action by: Dir. CA&PD Deptt)

7. The SMC shall launch cleanliness drive at the places where main congregations of Eid-ul-Azha will be held as per past practice. Besides, they will also ensure that all street high mast lights are made functional. The SMC shall also take necessary measures for filling of ditches (if any) and leveling of soil in Iddgah ground so that the congregational prayers will be held in a comfortable



way.SMC will ensure that no sale/slaughtering of sacrificial animals shall take place on the side, besides SMC authorities shall ensure that the identified spots where sale of sacrificial animals is taking place shall kept clean on regular basis.

- 8. RTO, Kashmir in consultation with the Transporters shall make all the necessary arrangements on the routes leading to the important mosques/shrines for facilitating to the commuters at identified bus bays.

- 9. The Health Officer, SMC shall ensure frequent checks of the markets to ensure availability of quality food products like bakery, milk, vegetables, fruits, etc in Srinagar city.

 (Action by: Health Officer, SMC)
- 10. Animal Husbandry Deptt. shall ensure the availability of poultry birds on notified rates and also give wide publicity where from poultry birds shall be kept available for general Public on this occasion. Besides, Sheep Husbandry Department shall ensure availability of sacrificial animals (Sheep/goats) on the occasion for convenience general public).

 (Action by:Dir. Animal Hubandry/Sheep Husbandry)
- 11. R&B Deptt. to take stock of repairing work of the all location of Srinagar City where main congregations of Eid-Ul-Azha are expected and also ensure to clear all debris and remove all the construction material lying on the road sides. (Action by:CE, R&B Deptt)
- 12. Fire and Emergency Department shall ensure availability of fire tenders at all important locations on the occasion of Eid-Ul-Azha as per the past practice.

 (Action by:DG Fire & Emergency Services)
- 13. SSP, Traffic city/Rural/RTO, Kashmir/JKSRTC shall jointly prepare a traffic management plan/routes for operation of buses / Mini buses on different routes on the valley on the day of Eid-Ul-Azha upto late hours as per the past practice to avert traffic jamming and to ensure proper parking slots available at all places especially Jamia Masjid, Iddgah and Hazratbal Shrine.

- 14. Health Deptt. shall set up medical aid camps at all important locations as per past practice.

 (Action by:Dir. Health Services/HoD,SPM C/o GMC Sgr)
- 15. All Deputy Commissioner including DC Srinagar shall deploy duty Magistrates on the day of Eid- ul-Azha at all the important locations especially Iddgah; Khanyar; Hazratbal; Sonwar; Jamia Masjid etc. Besides they shall also deploy Executive Magistrates at identified Sacrificial animal mandies to check out the rates fixed by the concerned authorities. Besides, DCs of all districts of Kashmir Division shall review the arrangements in their respective districts, also necessary law and order arrangements, ensure availability of essential commodities including sacrificial animals (Action by:All DCs/Dir CA & PD Deptt)
- 16. Lakes and waterways Dev. Authority Srinagar shall ensure cleanliness of Hazratbal Ghat and other places of prayers within its jurisdiction on the eve of Eid-ul-Azha.

 (Action By: VC, LAWDA)
- 17. Police authorities of all the districts shall prepare a separate security plan on the eve of Eid-ul-Azha functions.

 (Action by: SSP, Security Kmr)

Summing up the meeting, the Chair desired that:-

- All the departments must adhere to the SoPs and implement them on ground in letter and spirit
- Ensure strict compliance as per the decisions taken.
- All the concerned officers should be readily available in case of emergency.
- The essential commodities shall be made available with reasonable rates and standard quality.

All the Deputy Commissioners of Kashmir Division except DC, Anantnag/Kargil/Leh (through VC) were directed by the Divisional Commissioner Kashmir to put in place all necessary arrangements for the upcoming occasion without fail.
