Subject: Minutes of the review meeting regarding bottlenecks of various developmental issues of Downtown (Shehri-Khas) of Srinagar city.

A meeting was held under the Chairmanship of Shri Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir on 28.08.2018 at 11.00 A.M. to review the action taken on the decisions taken in the meeting held on 09.06.2018.

Following Officers participated in the meeting:-

1. Deputy Commissioner, Srinagar
2. Collector, Land Acquisition, KZP Project (Addl. Deputy Commissioner), Srinagar
3. Superintending Engineer, PW (R&B) Department, Srinagar-Budgam/ Circular Road Project, Srinagar
4. Representative from SMC, Srinagar

At the onset, Divisional Commissioner, Kashmir sought feedback from the concerned Officers regarding the decisions taken in the previous meeting. Accordingly, directions were issued by the Chair regarding the below mentioned issues.

1. Old Zaina Kadal Bridge:

Superintending Engineer, CRP, Srinagar will place the indent of the structures to be acquired before the Collector, Land Acquisition, CRP (Addl. Deputy Commissioner), Srinagar within three days.

(Action by: SE, CRP, Srinagar)

2. Demolition of structures at Gadyari:

Executive Engineer, R&B concerned under the supervision of Collector, Land Acquisition, KZP/CRP shall ensure that the 04 No. structures, for which HLC has already been conducted, are demolished within 10 days.

(Action by: Xen, R&B Concerned/Collector, LA, CRP, Sgr)

3. Construction of Community Halls at Kawdara and Namchabal:

The Chair directed that this office will take up the matter with H&UDD Department for release of funds. For Community hall at Namchabal where 05 out of 06 structures have been acquired under compulsory mode, the left out structure shall be placed in the next HLC meeting to be conducted within one week for approval of rates/compensation.

(Action by: ACC, Kmr/SE, CRP, Sgr)

4. Construction of Community Halls at Fateh Kadal and Aziz Park, Khanyar:

SE, PWD/CRP, Srinagar shall place indent of all the structures to be acquired, pertaining to both the sites, before the Collector, Land Acquisition, KZP/CRP within a week's time so that the acquisition proceedings are initiated in the matter.

(Action by: SE, CRP, Sgr)

5. Structures at Baba Demb:

Collector, Land Acquisition, CRP, Srinagar informed the Chair that there is no land available to rehabilitate the families to be relocated. It was decided that Rs. 10.00 lacs per family be paid to them in lieu of plots. Decision regarding the same will be taken in the next HLC after negotiating with the affected families.

(Action by: Collector, LA, CRP, Sgr)

6. Shopkeepers at Khanyar on KZP road Project:

Both the cases shall be placed before the next HLC meeting to be conducted within one week. SE CRP will ensure that the notice for next HLC meeting shall be issued within 05 days.

(Action by: SE, CRP, Sgr)

7. Fire Service Station at Maharaj Gunj:

The Chair directed that this office will take up the matter with Home Department for establishment of the fire station, for which the proceedings for transfer of land have already been initiated.

(Action by: ACC, Kmr)

8. Jamia Masjid Community Hall:


The Chair directed DC, Srinagar to ensure that the encroachment on the plot, earmarked/allotted to the family getting dislocated, is removed so that its possession is handed over to the beneficiary who has partially demolished his structure.

(Action by: DC, Sgr)

9. DC Srinagar will take review of the implementation of above mentioned directions after 10 days and submit the action taken report to this office for kind perusal of Divisional Commissioner, Kashmir.

(Action by: DC, Sgr)

The meeting ended with a vote of thanks to and from the Chair.
