Minutes of the meeting held under the Chairmanship of Divisional Commissioner Kashmir on 31.10.2017 in connection with arrangements for observance of Urs-i-Sharief of Hazrat Makdoom Sahib<sup>RA</sup> at Kohimaran, Nowhatta/Makdoom Mandow, Kalashpora, Srinagar/ Ahim-i-Sharief, Bandipora/Tujjar Sharief, Tujjar,

A meeting under the Chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner Kashmir was convened on 31.10.2017 to finalize the arrangements to be made by various departments in connection with the celebration/observance of Urs-i-Sharief of Hazrat Makdoom Sahib<sup>RA</sup> at Kohimaran, Nowhatta/Makdoom Mandow, Kalashpora, Srinagar/Ahim-i-Sharief, Bandipora/Tujjar Sharief, Tujjar, Sopore District Baramulla.

List of participants is enclosed as Annexure-A.

At the outset, the Divisional Commissioner, Kashmir welcomed all the participants and the Chair informed that the Urs Mubarak is commencing from 11<sup>th</sup> Safar-ul-Muzaffar upto 24<sup>th</sup> Safar-ul-Muzaffar corroborating to 1<sup>st</sup> November, 2017 to 14<sup>th</sup> November, 2017. The Chair intimated that the Hon'ble Chief Minister has desired to make elaborate arrangements for the purpose so that the zayireen do not face any inconvenience and impressed upon the Officers to personally monitor the arrangements to be made by their respective

After threadbare discussions with all the concerned Heads of Department / Deputy Commissioners, the following decisions were taken:-

Police Department shall make adequate security arrangements at the venues of the Urs during the Urs days.

(Action by: IGP Kmr, SSP, Sgr/ Sopore)

Engineer, Electric (PDD), Kashmir shall ensure uninterrupted electric supply to the areas during the Urs days where the Urs Sharief is being observed/celebrated. Besides, she shall ensure that one D.G. Set of adequate capacity is installed at the Shrine at Tujjar Sharief, Sopore.

(Action by: CE, PDD, Kashmir)

3) Director, Food, Civil Supplies CA & PD Department, Kashmir shall ensure availability of essential commodities i.e. rice, sugar, atta, k.oil, L.P.G. etc to the people especially in the areas where the Urs is being celebrated.

(Action by: Dir, FCSCA&PD, Kashmir)

4) Chief Engineer, PHE, Kashmir shall ensure uninterrupted water supply to the areas during the Urs days where the Urs Sharief is being observed/celebrated. Besides, water tankers, one each at the Shrine at Kohimaran, Nowhatta, Srinagar; and Tujjar Sharief, Tujjar, Sopore remain available round the clock during the Urs days.

(Action by: CE, PHE, Kashmir)

5) Director, Health Services, Kashmir shall arrange free medical camps for 07 days at all the locations during the Urs days and shall issue duty roaster in respect of Medics and paramedics. Ambulances shall also be kept at stand-by at all the venues.

(Action by: Dir., Health Services, Kmr)

6) General Manager, J&K State Forest that firewood be provided to these Shrines on priority in view of the cold climate so that Hamams are made operational/functional and the zayireen do no face any inconvenience on this count.

(Action by: GM, SFC Kashmir)

 Non functional and damaged street lights on all streets in and around the Shrines shall be made functional by PDD / SMC / Urban Local Bodies.

(Action by: CE PDD Kmr/ Comm. SMC/Dir. ULB Kmr)

8) Chief Engineer PWD (R&B) Kashmir shall ensure that repairs/ renovation/filling of potholes of Ziyarat road from Gurpal to Bus Adda at Tujjar Sharief, Sopore is conducted within two days.

(Action by: CE, R&B, Kashmir)

10) Sr. Superintendent of Traffic (City), Srinagar shall ensure regulation of traffic on all the routes leading to Kohimaran, Nowhatta and parking of vehicles at the Shrines.

(Action by: SSP Traffic City, Srinagar)

11) Srinagar Municipal Corporation/Municipal Committee concerned shall start special sanitation/cleanliness drive in and around the Shrine areas during the Urs days.

(Action By: Comm. SMC & Dir, ULB Kmr)

- 12) Fire & Emergency Services shall keep available adequate fire tenders near the Shrines located at Kohimaran, Nowhatta/ Mandow, Kalashpora, Srinagar/Ahim-i-Sharief, Bandipora/Tujjar Sharief, Tujjar, Sopore District Baramulla.
