Record note of the meeting held under the Chairmanship of Mr. Baseer Ahmad Khan, IAS Divisional Commissioner, Kashmir on 24.11.2017 regarding construction of school buildings, roads and bridges under World Bank Project.

A meeting under the Chairmanship of Mr. Baseer Ahmad Khan, IAS Divisional Commissioner, Kashmir was held on 24.11.2017 at 11.30 A.M. to review the progress regarding construction of school buildings, roads and bridges under World Bank Project.

At the outset, the Divisional Commissioner, Kashmir welcomed all the participants of the meeting and informed them that 222 Projects at a cost of Rs. 5,000 crores have been approved under World Bank Project. Out of the approved projects, 53 schools, 09 roads and 08 bridges will be constructed by PW (R&B) Department, Kashmir. Similarly 17 bridges and 4 roads will be constructed by J&K Projects Construction Corporation. The Chair impressed upon the Deputy Commissioners/Director, School Education/Chief Education Officers to ensure furnishing of requisite revenue documents/Need Assessment Certificates/non-encumbrance certificate, NOCs, etc. to the concerned without further loss of time so that the projects get a kick off.

After having threadbare discussions with all the concerned, the following decisions were taken:-

1. Chief Education Officers concerned will furnish the requisite "Need Assessment Certificates" and other requisite certificates in respect of the schools identified under World Bank Project to the respective Deputy Commissioners with intimation to Director, School Education, Kashmir by or before Monday i.e. 27.11.2017

who in-turn will forward the same to the concerned Superintending Engineers PW (R&B) Department on the same day.

2. Deputy Commissioners will get the revenue papers and nonencumbrance certificates prepared by the sub-ordinate revenue agency and forward the same Superintending Engineers PW (R&B) Department for further necessary action.

3. Wherever non-encumbrance certificate in respect of any school cannot be furnished for any reason, what-so-ever, Deputy Commissioners shall exclude the said school from the list of the already identified schools and include a new school in place of the deleted one.

4. Type Design in respect of the schools will be finalized by the Chief Engineer, PW (R&B) Department, Kashmir in consultation with Chief Executive Officer, Jhelum & Tawi Flood Recovery Project, J&K.

(Action by: CEO, J&T Flood Rec. Project/CE, PWD (R&B) Kmr)

5. Chief Executive Officer, Jhelum & Tawi Flood Recovery Project, J&K will provide a copy of the guidelines of the World Bank on the said Project to this office and Deputy Commissioners concerned.

6. After receipt of the requisite certificates from the CEO, Deputy Commissioners will issue necessary instructions to the concerned to formulate the DPRs. The DPRs acquisition, if any, cost of demolition any other component which would assessment, to avoid any additional costs/framing of revised DPRs at a later stage.

7. Chief Engineer, PW (R&B) Department, Kashmir will engage consultancy for grant of interim relief and submit the proposal to the Chief Executive Officer, Jhelum & Tawi Flood Recovery Project, J&K who will accord necessary approval as agreed to in the meeting.

8. Deputy Commissioners will ensure that NOCs from Irrigation & Flood Control Department in respect of bridges and NOCs from Forest Department in respect of roads, if required, be obtained before executing the projects.

9. District Dev. Commissioners will Commissioners of their respective districts as Nodal Officers for the World Bank Projects. However, not posted in any district, Deputy any other suitable Officer as the Nodal Officer and inform all the concerned accordingly.

10. Deputy Commissioner, Anantnag will issue necessary certificates/ revenue papers in respect of roads joint survey by a team of Officers from Revenue Department & Engineering wing by or before 30th December, 2017.

11. Deputy Commissioner, Srinagar/ Budgam/ Baramulla/ Bandipora/ Pulwama/ Anantnag/ Kulgam/ Shopian will issue necessary certificates /revenue papers in respect of roads and bridges after conducting joint survey by a team of Officers from Revenue Department & Engineering wing by or before 2nd December, 2017.

12. Deputy Commissioner, Srinagar will resolve the issue of Environment Assessment Report in respect of L.D. Hospital, Srinagar within two days.
