Subject: Vist of Divisional Commissioner, Kashmir to Dal Lake Srinagar.


TOUR NOTE

Divisional Commissioner, Kashmir took an extensive Tour of Dal Lake alongwith Superintending Engineer LCMA, Executive Engineer LCMA and Naib Tehsildar LCMA on 23-11-2021, visited various Mohallas viz; Tinda Mohalla, Sofi Mohalla, Kanda Mohalla and vegetable floating market inside the Dal Lake and held extensive discussions and deliberations with the Dal Dwellers. He assured them that all the basic facilities will be provided by the Govt. at Rakh-i-Arth Housing Colony Bemina Srinagar including Schools, Health Centre, Drinking Water facilities etc besides a separate Municipality will also be provided for the Rakh-i-Arth Housing Colony Bemina Srinagar.

After threadbare discussions the following directions were passed by the Divisional Commissioner, Kashmir which are as under:

1.	Widening of Navigation Channels.	Naib Tehsildar LCMA shall prepare a map in consultation with Principal, Revenue Training Institute Srinagar for widening of Navigation Channels inside the Dal Lake.	Naib Tehsildar LCMA Srinagar
2.	Dweeding of lily.	Superintending Engineer LCMA shall identify suitable patch of lily areas and frame the proposal for traditional dweeding by utilizing the services of Dal Dwellers having experience in traditional Dweeding. Action Plan in this behalf shall be framed within 10 days.	S.E. / Exen LCMA Srinagar
3.	Beautification of floating vegetable market	Vice Chairman LCMA and Superintending Engineer LCMA shall prepare a plan for beautification of floating market at Dal Lake by providing the necessary logistic support viz dust-bins, portable toilets etc, so that maximum number of tourists can visit inside the Dal Lake and basic facilities are also provided to the Dal Dwellers.	VC / S.E. LCMA Srinagar
4.	Development of few as model villages	Vice Chairman LCMA shall frame a pilot proposal for 03 to 04 villages in coordination with Dal Dwellers Association for beautification of these villages as model villages by providing dust-bins, vermi compost pits etc, so that these villages can be made attractive for tourists.	VC LCMA Srinagar

5.	Rehabilitation of Dal Dwellers as per existing SOR.	Dal Dwellers alleged that they are being compensated with 2011 schedule of rates and are hence facing monetary losses. Divisional Commissioner, Kashmir directed that Vice Chairman LCMA shall explore the possibility of providing rehabilitation package to Dal Dwellers as per current schedule of rates instead of 2011. 6.	Partial acquisition of land	It was appraised to Divisional Commissioner, Kashmir that the houses / dongas of some of the dwellers rehabilitated at Rakh-i-Arth, have been acquired but their proprietary land has not been acquired or partially acquired which gives apprehensions for encroachment of the acquired land by the adjoining existing Dal Dwellers. Divisional Commissioner, Kashmir directed the Naib Tehsildar to conduct an extensive survey of such cases whose land has been partially acquired and submit the list to Vice Chairman, LCMA and Divisional Commissioner, Kashmir within 10 days. 7.	Providing basic facilities at Rakh-i-Arth	Commissioner, SMC / Director Floriculture / School Education / Health Services Kashmir, Chief Engineer, R&B / PHE / KPDCL Kashmir shall provide all the facilities at Rakh-i-Arth Bemina pertaining to their departments.	Commr. SMC / Dir. Floriculture / DSEK / DHSK / C.E. R&B / PHE / KPDCL Kashmir
