**Subject: Minutes of the Review meeting held on 26-04-2018 regarding streamlining of traffic regulations in Kashmir Division.**


A review meeting under the Chairmanship of Divisional Commissioner Kashmir was convened on 26-04-2018 at 12. 30 Noon in order to streamline traffic regulations in Kashmir Division.

Following officers attended the meeting:

At the outset Divisional Commissioner impressed upon the participants to ensure palpable action for de-congestion of traffic mess in Kashmir Division in general and Srinagar city in particular. He sought action taken report from respective departments/associations pursuant to the earlier meetings held in the instant matter with explicit focus on overloading, reservation of seats for ladies, Timing of public transport, fare concession to the students, uniform usage by drivers/conductors plying public transport, ladder laden and roof topping.

Inspector General of Police Traffic J & K apprised the chair about various issues regarding decongestion of Traffic in Kashmir Division so as to streamline the traffic management. He persisted that various Transport Associations have to show seriousness in implementation of directives issued from time to time.





After threadbare discussions, the following decisions were taken:

1. Regional Transport Officer, Kashmir shall send a team of officials who will board the buses/Mini buses etc to physically calculate timing taken by KMDA and Mini Bus public transporters en-route distinct routes on all districts from Srinagar; to & fro. Besides report whether fare concession to the students is practically given to the students or not and also report control on ladder laden and roof topping. Regional Transport Officer, Kashmir shall submit report to this office through Traffic Advisor, J & K.

2. KMDA/Mini Bus Association/Sumo Stand Association have been given five days time while as Auto Rickshaw Association has been given ten days time to ensure that their drivers /conductors on all routes put on uniform while plying public transport. They shall abide by the circular instructions issued from time to time in this regard. Strict cognizance shall be viewed with regard to intake of seating capacity, regulation of rates and use of uniform, over-speeding & over boarding besides, discount for students. Auto Rickshaw Association shall ensure installation of meters. Report to this effect shall be submitted to this office by SSP Traffic City Srinagar & SSP Traffic Rural, Kashmir respectively through Traffic Advisor J & K.

3. Commissioner, Srinagar Municipality shall deploy nafri e20 at Parimpora in Srinagar for cleaning of debris. Chief Engineer PHE shall ensure uninterrupted water supply at Parimpora. Chief Engineer, PWD (R&B) Department Kashmir will ensure face lifting and macdamization in Srinagar city in pursuance of directions in the previous meetings in the instant matter.

4. KMDA/Mini Bus Association/Sumo Stand Association/Auto Rickshaw Association have also been directed to impart counselling sessions for their respective drivers/conductors to adhere to the rules and regulations imparted from time to time and consequences in case of non-compliance in this regard.





5. It has directed that music system nuisance being used in public transport is to be stopped. All Presidents of KMDA/Mini Bus Association/Sumo Stand Association/ Auto Rickshaw Association have been directed that music system used by their respective drivers in public vehicles shall be stopped forthwith within two days. Afterwards, Deputy Commissioners of all Districts have been directed /authorized to send their team in the market place to seize music players in any public transport vehicle in case of violations.
