1	Shabby High Rise tin enclosures, metal pipes and other waste material in and around Sher-e-Kashmir Cricket Stadium.	The tin enclosures which obstruct the view of the playground alongwith other waste/junk material needs to be removed immediately.	IGP CRP/ SSP Sgr./ Comr. SMC	Since the area is Sub-Judice before the Hon'ble Court. However, matter will be taken up with the Secretary Sports Stadium with the instructions that obstruction on account of tin sheet be set right without violating the court directions.
2	Re-designing and face lifting of dreadful and shabby bunkers for making them attractive without compromising on security.	Services of Urban Planners and fine Art professionals needed to be roped for complete makeover of vital security points/bunkers so as to present a positive image.	IGP CRP/ SSP Sgr./	SMC erected view cutter & IGP CRPF was directed to built up the bunkers properly. Director Radio Kashmir was also directed to provide the space to IGP CRPF so that he may build up the bunker. In the mean time CRPF will remove the road side bunker at Radio Kashmir, Palladium Cinema & other places. IGP assured that it will be done within 10 days. DC Srinagar will direct VC SDA, Dir. ULB and IGP CRPF will nominate a nodal officer for all purposes to deal with the matter of different kinds.

4	Removal of billboards, hoardings and other eye-sore at prominent places.	Ugly and shabby boards and hoardings need to be removed immediately.	Comr. SMC/ Dir. Tourism	SMC has removed the ugly & shabby boards and hoardings. Div Com directed SMC to re-design the bill boards / hoardings immediately within 01 week
5	Repairs of footpaths, lanes, drains and face uplifting of various roads leading to various tourist destinations.	Immediate necessary repairs and alternations need to be carried out in respect of road in and around the city.	CE UEED/ Dir. Tourism I&FC/R & B Comr. SMC/	Comm. SMC / SE R&B / Dir. Tourism Kashmir was directed to carry out the necessary repairs & alterations of roads / lanes (if any) within Srinagar City within 01 week.
6	Waste management and cleaning of roads sides, pathways, removal of weeds debris and other junk material.	Immediate necessary steps need to be undertaken.	Comr. SMC	Comm. SMC was directed to lift the entire debris within 01 week and submit the compliance report.
7	Removal of junk and other waster material in and around Zero Bridge.	Immediate necessary steps need to be undertaken.	Comr. SMC/ MD JKPC/ GM JKTDC	JK TDC was directed to remove of junk and other waste material in and around Zero Bridge.
8	Deteriorating condition of wooden planks used for refurbished Zero Bridge and Food court has been viewed seriously.	It was decided that a high level committee shall be constituted by Regional Director NOIT Srinagar for undertaking comprehensive study with regard to the quality of material along with the specifications of the material used and submit a detailed report accordingly o the Hon'ble Minister for Revenue with a period of one month positively.	Regional Director NIT Srinagar.	Regional Director NIT was directed to complete the job as already ordered within fixed time frame fixed by the Hon'ble Minister.
