Subject: Minutes of review meeting held under the chairmanship of Divisional Commissioner Kashmir on 14/07/2021 regarding the arrangements for commemoration of Muharram-ul-Haram, 1443 (Hijri).

A meeting under the chairmanship of Shri Pandurang K. Pole (IAS), Divisional Commissioner, Kashmir was held on **14/07/2021** at **03:00 PM** regarding the subject cited above.

At the outset of the meeting, the chair welcomed all the participants impressed that Muharram-ul-Haram, 1443 (Hijri) shall be celebrated as per the past practice, however, in view of spread of COVID-19 all the SOPs / guidelines shall be adhered in letter and spirit.
