Sub: Minutes of review meeting regarding arrangements for celebration of birth anniversary of Guru Gobinji Mahraj (Prakash Utsav) falling on 05-01-2019.

A review meeting was held under the chairmanship of Divisional Commissioner, Kashmir on **03.01.2019** to finalize the arrangements to be made for celebration of birth anniversary of Guru Gobind Singh Ji Mahraaj by various departments including police department.

Following officers attended the meeting:

- 1) Deputy Commissioner, Srinagar.
- 2) Additional Commissioner, Srinagar Municipal Corporation.
- 3) Director FCS & CA, Kashmir.
- 4) Chief Engineer, PDD (EM & RE), Kashmir.
- 5) Chief Engineer, PHE, Kashmir.
- 6) Joint Commissioner, Srinagar Municipal Corporation.
- 7) Sub Divisional Magistrate East, Srinagar.
- 8) Sr. Superintendent of Police, Traffic, City.
- 9) Deputy Director Health Services, Kashmir.
- 10) Superintending Engineer, Hydraulics Srinagar.
- 11) Deputy Superintendent of Police, Srinagar.

After threadbare deliberations, following decisions were taken:-

1. Srinagar Municipal Corporation shall ensure that sufficient dedicated Safai Karamcharies are deployed at Chatti Padshahi and other Gurdawaras during the Prakash Utsav. The corporation shall also ensure availability of dustbins and mobile toilets at Chatti Padshahi during the Prakash Utsav.

(Action by: Commr. SMC)

2. Power development department shall ensure un-interrupted power supply at Chatti Padshahi and other Gurdawaras during the Prakash Utsav. High-mast lights and other lights shall be made functional or replaced/repared wherever non-functional. A dedicated genset shall be made available at Chatti Padshahi during the Prakash Utsav.

(Action by: CE, PDD, EM&RE, Kmr)

3. PHE Department shall ensure potable water supply during festival at Chatti Padshahi and other Gurdawaras. PHE will also ensure availability of a water tanker at Charipadshahi Rainawari Srinagar.

(Action by: CE, PHE Kmr)

4. Deputy Commissioner Srinagar shall constitute a unitary Joint Control Room at Chatipadshahi wherein Sub-Divisional Magistrate Srinagar (East) shall be the nodal officer. Line departments shall share information of officers/officials together with their contact numbers with the unitary nodal officer.

(Action by: Deputy Commissioner Srinagar/SDM East)

5. Arrangements of essential commodities including Sugar, K-oil and LPG during the Prakash Utsav shall be ensured. The department of FCS&CA Kashmir shall provide additional quota of ration, atta, sugar & domestic LPG at the disposal of Secretary Gurudwara Parbhandhak Committee Srinagar.

(Action by: Dir. FCS & CA Deptt)

6. Necessary arrangements of route plans en-route Chatipadshahi shall be made. Jointly traffic management plan be made for operation of buses /Mini buses on different routes as per past practice to avert traffic jamming. Parking slots at Gurduwara, Marriage Hall and Makhdoom Sahab Gandola base shall be identified and depicted in black and white on road besides information through electronic media about it.

(Action by: RTO, Kmr/SSP,

Traffic, City/MD JKSRTC)

7. Fire and Emergency services shall ensure availability of a fire tender at Chatipadshahi and get hydrants audited.

(Action by: JD, Fire & ES, Kmr)

8. Medical aid camp with para-medical team at Chatipadshahi shall be established. One Ambulance shall be kept standby for convenience of devotees in case of exigency. One lady doctor shall also be deployed at Chatipadshahi during Prakash Utsav.
