MINUTES OF THE MEETING HELD REGARDING ISSUES/
DEMANDS RELATED TO VARIOUS MIGRANT WELFARE
COMMITTEES OF DIFFERENT TRANSIT CAMPS LOCATED
IN KASHMIR VALLEY.

A meeting was held under the chairmanship of Divisional Commissioner, Kashmir on 01.11.2018 at 12. 30 AM in the Meeting hall of this office, in order to redress the issues raised by Migrant Welfare Committee and migrant employees in Kashmir valley.

Deputy Commissioner, Ganderbal/Anantnag/Baramulla/Kulgam/ Kupwara/Pulwama/Budgam attended the meeting through Video Conference.

At the outset, the Divisional Commissioner Kashmir asked Chairman Migrant Coordination Committee to articulate the issues and problems being faced by them.

The chair was informed that the main problems faced by the migrant brethren include the shortage of essential amenities viz, ration, power, drinking water and healthcare. The issues of non-completion of construction works at KP colony Vessu

Kulgam, Baramulla, Ganderbal, Mattan & Model School at Vessu Sheikhpora/Veervan etc were raised.

The Chairman Migrant Coordination Committee also requested for improved security in Nutnusssa Migrant camp Kupwara and other migrant camps. He also contended that Deputy Commissioner Kupwara has not paid a single visit to the far flung migrant camps to review the arrangements or stock of basic amenities.

The chair directed the district magistrates to set aside extraneous slots and review the demands of migrant community. Individual observations were sought from respective district magistrates. He issued directives for immediate action for redressal of the issues raised by Migrant Welfare Committee and migrant employees in Kashmir valley. However; as far as demand of separate accommodation of each family was concerned, the Divisional Commissioner assured that since the administration is in process of establishment of tenements, this issue will be resolved bi-default.

After threadbare discussions, following decisions have been passed:

In The construction works at KP colony Vessu Kulgam, Baramulla, Ganderbal, Mattan etc shall be speeded up. Concerned Deputy Commissioners shall review the issues and submit compliance within one week. Relief & Rehabilitation Commissioner, Migrants, J & K shall visit Lar, Ganderbal to take stock of feasibility of alternate land identified by Deputy Commissioner Ganderbal.

(Action to be taken by: RCM All DC's).

2. Deputy Commissioner Kupwara will visit transit camp Nutnussa Kupwara and submit report of proper functioning of medical facilities and availability of doctors/ration. Deputy Director Food, CS & CA will also visit transit camp Nutnussa and ensure availability of ration, K-oil, LPG etc under relief and non-relief categories so that beneficiaries don't face any difficulty.

(Action to be taken by: DC Kupwara/ Director Food, CS & CA).

3. Repairment work of street lights shall be started in migrant colony Hawal Pulwama and other areas where Kashmiri Pandits/employees are residing. Funds; pending, if any; shall be released separately.

(Action to be taken by: CE-PDD).



4. PHE Department will ensure availability of water supply in Veerwan Pandit colony Baramulla and other areas where Kashmiri Pandits/employees are residing.

(Action to be taken by: CE-PHE).

5. As far as payment of rent, posting of employees and conducting of DPC's is concerned, the Divisional Commissioner directed that such issues require specific details from intending employees and involve and Specific Practice and Rule. The matter shall be put up in black & white before the chair by concerned employees through indenting department so that the same is submitted to the government for concurrence or resolve of impediment, if any.

(Action to be taken by: Migrant employees).

6. A report of compliance shall be furnished by all line departments in a fortnight time.

(Action to be taken by: All DC's/.Dir- SEK/ FCS & CA/ Health/ Chief Engineer, PHE, /R & B, /RDD).

The meeting ended with a vote of thanks to the chair.
