A meeting under the Chairmanship of Divisional Kashmir, was held on 19-12-2017 regarding review the Developmental works of Hazratbal shrine.

AT the outset the chair informed that the Hazratbal shrine has been approved under PRASAD at estimated cost of Rs. 42.02 Crores and is being executed by the Tourism Department, Housing Board and also various components of the project are being executed by JKPCC, SICOP, Cable Car Corporation and LAWDA and the details of the works is given as under:-

3.	Public Conveniences shopping Kiosks and multi level parking , Toilet facilities, Construction of tourist Facilitation Centre, Provisions of Signages, Provision for multi storey car parking	JKPCC
4.	Mechanized Tensile Structure for covering outer prayer area	SICOP
5.	Iron fencing of lake, Rejuvenating Dal Lake front and fountains, Sufi Interpretation, Tourist facilitation and signage's etc.	J&K Cable Car Corporation.
6.	Provision of aerators for rejuvenating Dal Lake front and fountains for Hazratbal Shrine precinct.	LAWDA

After threadbare discussions, the following decisions were taken:-

1. The Deputy Commissioner Srinagar, CEO Wakf Board and General Manager JKPCC Kashmir will visit the various spots at Hazratbal and Wakf Board will give the demarcation of site and for construction of inner approach road within 2 days. The Chair directed that Director Tourism/JKPCC to start the work immediately after taking over the demarcation of the project road.

2. Director Tourism informed the Chair that 90% of illumination work has been completed and the remaining work will be completed immediately.

3. The Housing Board will start work of Providing and laying of Devri Stones and other works within one week. Deputy Commissioner Srinagar will verify the contents of the land within 2 days in consultation with the LAWDA for establishment of light and sound show. The Chair directed that the work should be completed by ending June, 2018.

4. The Chair directed General Manager SICOP Kashmir to start the work of Mechanised Tensile Structure for covering outer prayer area within 15 days and should be completed by December 2018.

5. The Chair directed Managing Director, Cable Car Corporation to speed up the pace of work on Iron fencing of lake, Rejuvenating Dal Lake front and fountains, Sufi Interpretation, Tourist facilitation and signage's.

6. The chair directed that V.C LAWDA should start the work on provisions of aerators for rejuvenating Dal Lake front and fountains for Hazratbal Shrine precinct immediately.
