Subject:- Review meeting of Pradhan Mantri Kisan Man Dhan Yojna (PM-KMDY)scheme.

A meeting under the chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir was held on 19.10.2019 at 11.00 AM to review the progress of Pradhan Mantri Kisan Man Dhan Yojna (PM-KMDY) scheme.

List of the participants is annexed as Annexure-A.

At the outset, the the chair informed about the Pradhan Mantri Kisan Man Dhan Yojna (PM-KMDY) which is a voluntary and contributory old age pension scheme for the entry age group of 18 to 40 years for full time farmers. The scheme is meant for all land holding small and marginal farmers (S&MFs) which provides an assured monthly pension of Rs 3000 to all S&MFs on attaining the age of 60 years. As contributory pension scheme, a monthly contribution in the range of Rs 55 to Rs 200 per month has to be paid by the full time farmers depending upon their age.

Thereafter, the chair took feedback from all the Deputy Commissioners about the action taken in the matter.

After threadbare discussion, the following directions were passed:-

Chief Agriculture Officers are nominated as Nodal Officer for the enrolment of eligible and desirous SMFs with full details. The filled in forms shall be uploaded on Ntional Portal at internet Kiosks which are already established in the Deputy Commissioner office. Three computers shall be kept reserved at the respective DC Offices for the said activity and officials from Agriculture /Horticulture Departments shall be deputed for this purpose.

All Deputy Commissioners along with Agriculture and Horticulture departments shall organize seminars, awareness camps and public interaction programmes in all Agriculture zones in their respective districts and propagate the pensioner benefits of PM-KMDY scheme among the farmers. Besides the zone level schedules shall be framed and shared with Deputy Commissioners for onward submission to this office.


