Subject:- Meeting regarding Finalizing of SOPs for smooth plying of Traffic on Ganderbal-Kargil/Leh Road.

A Meeting held under the chairmanship of Divisional Commissioner Kashmir on 20/11/2019 at 3.00 PM regarding finalizing of SOPs for smooth plying of Traffic on Ganderbal-Kargil/Leh Road.

Following Officers participated in the meeting:-

- 1. Deputy Commissioner, Ganderbal (through VC).
- 2. SSP Ganderbal (through VC).
- 3. SSP Traffic Rural, Kashmir.
- 4. Col. Mukesh Khanna/Col. Y.L Suresh (From BEACON).

At the outset, the Divisional Commissioner, Kashmir sought feedback from all the participants regarding the Ganderbal- Kargil/Leh Road. After taking feedback following instructions/SOPs have been given which shall be effective from today:-.

1. Sr. Superintendent of Police, Ganderbal shall be the Nodal Officer for taking call as to whether traffic including army vehicles shall be allowed to ply or not on Ganderbal-Kargil/Leh Road.

(Action by: - SSP Gbl).

3. SSP Ganderbal shall take the call and make announcement 12 hours prior. Before, announcement he shall take into account the status of road provided by the BEACON Authorities, Trafficebility of the road from SSP Traffic Rural. Beside, MET reports/SASE on daily basis.

(Action by: - SSP Gbl/CE, BEACON/SSP Traffic Rural).

6. BEACON authorities while giving the report of road being open shall specify the type of vehicle/s to be allowed and with what wherewithal (chains etc).

(Action by: - BEACON)

7. The BEACON authorities shall clear the road using full men and machinery. Besides, shall apply chemicals on the road on daily basis.

(Action by: - BEACON)

8. As conveyed by the BEACON Authorities traffic is likely to be resumed by Wednesday (4th of December 2019). However, in view of the apprehensions ventilated by BEACON traffic shall be strictly one way .The same shall be ensured by the authorities from Kargil side also.

11.General Manager, BSNL shall immediately depute officer/officials responsible for operating BSNL Tower at Rang Mode at Ganderbal-Kargil Road without any fail. Chief Engineer, BEACON shall confirm his availability within 3 days time.

(Action by: - GM BSNL)

13. All the agencies shall strictly adhere these SOPs in letter and spirit and any one found violating shall be taken to task as per the law.

(Action by: - DC/SSP Gbl/Traffic Deptt./BEACON)
