Subject:- Meeting regarding damage caused to Kounsarbal, Tral Shrine and its reconstruction.

A Meeting held under the chairmanship of Divisional Commissioner Kashmir on 28/11/2019 at 11.00 AM regarding the reconstruction of the Ladies Compound Kounsarbal, Tral Shrine which got gutted in an incident of fire.

At the outset, the Divisional Commissioner, Kashmir sought feedback from the Deputy Commissioner, Pulwama, SSP Awantipora, Chief Engineer R&B Kashmir, ADC, Tral and the Governing Body/Auqaf of the Shrine Kounsarbal with regard to the damages caused to the Ladies compound, Kounsarbal, Tral Shrine due to incident of fire on intervening night of November 25th & 26th, 2019 and its subsequent reconstruction. The chair was apprised that the structure of ladies compound was gutted in an incident of fire, after the fire was extinguished it was found that the structure had developed cracks and needs to be reconstructed. Chief Engineer R&B informed that the estimated cost of Rs.22.00 lacs will be required for its reconstruction.

After thoughtful deliberations and threadbare discussions the following decisions were taken:-

1. Divisional Commissioner, Kashmir approved the estimated cost of Rs.22.00 Lacs for reconstruction of damaged structure of the Ladies compound Kounsarbal Shrine as per the estimate conveyed by the Chief Engineer, R&B, Department. R&B, Department shall float the tender for the reconstruction of the Ladies Compound, Kounsarbal, Tral Shrine today positively and tendering process in this regard shall be completed within 10 days, and from 11th day the construction shall get underway.

2. The reconstruction work of the (Ladies Compound) Kounsarbal Tral Shrine shall be done in 03 months time positively on the similar pattern as of the gutted structure in consultation with local Auqaf.


3. The reconstruction work of the (Ladies Compound) Kounsarbal Tral Shrine shall be monitored by Deputy Commissioner, Pulwama/SSP Awantipora /Chief Engineer ,R&B and ADC Tral in consultation with the governing body/Auqaf of the shrine.

4. ADC Tral shall submit weekly reports through Deputy Commissioner, Pulwama regarding the progress of work done at (Ladies Compound) Kounsarbal Tral Shrine for onward submission to this office.
