Minutes of the meeting held under the Chairmanship of Divisional Commissioner Kashmir on 03.11.2017 regarding exploring avenues of parking facilities for vehicles in Srinagar city.

A meeting under the Chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner Kashmar was field on 03.11.2017 to explore the avenues of parking facilities for vehicles in Srinagar city.

List of participants is enclosed as Annexure-A.

At the outset, the Divisional Commissioner, Kashmir welcomed the participants and appreciated the efforts put in by Commissioner, Srinagar Municipal Corporation, Srinagar in getting the street vendors removed from the busy markets of H.S.H.S., Batmaloo and other adjoining areas. The Chair also lauded the efforts put in by Sr. Supdt. Of Police, Traffic (City), Srinagar in regulating the traffic. The Chair impressed upon the Officers to continue with this process.

After threadbare discussions, the following decisions were taken:-

1) Deputy Commissioner, Srinagar and Sr. Supdt. Of Police, Traffic (City), Srinagar shall again visit the already identified 28 parking slots at M.A. Road, Residency Road, Karan Nagar and other adjoining areas and submit report about their feasibility within two days.

(Action by: DC, Sgr, SSP, Traffic (City) Sgr)

2) Sr. Supdt., of Police, Traffic (City), Srinagar intimated that there is immediate requirement of improvement of stretch at Qamarwari. The Chair directed Superintending Engineer, PW (R&B) Department, Circle Srinagar/Budgam to take up the improvement work and complete within a week's time.

(Action by: SE, PWD, Sgr)

3) Sr. Supdt. Of Police, Traffic (City), Srinagar and Superintending Engineer, PW (R&B) Department, Srinagar/Budgam will make a joint visit to Barzulla Bridge and submit report about the feasibility of underpass road for movement of traffic, as suggested by SSP, T affic (City), Srinagar.

(Action by: SSP (T) City, Sgr/SE, PWD, Sgr)

4) Chief Engineer, Electric, Kashmir will send her representative with the Sr. Supdt of Police, Traffic (City), Srinagar to make a spot visit to Bemina Chowk in order to map out/mark the electric poles which are required to be shifted for ensuring smooth movement/free flow of traffic and submit report within two days.

(Action by: CE, Electric, Kmr/SSP (T) City Sgr)

5) Deputy Commissioner, Srinagar and Sr. Supdt. Of Police, Traffic (City), Srinagar will organize awareness camps and orient the general public about right/wrong parking of vehicles.

(Action by: DC, Sgr/SSP (T) City, Sgr)
