Subject: - Minutes of meeting held on 25-04-2018 under the chairmanship of Divisional Commissioner, Kashmir regarding drug de-addiction.

A meeting under the chairmanship of Divisional Commissioner, Kashmir was held on 25-04-2018 regarding various social issues with specific focus on drug addiction and to take necessary measures for drug de-addiction in Kashmir Division.

Among various Social activists of NGO's & Civil Society representatives, following officers attended the meeting:

- 3. Deputy Inspector General of Police, Central Kashmir Range.
- 4. Director School Education Department, Kashmir.

- 7. Senior Superintended of Police, Traffic City Srinagar.
- 8. HOD Psychiatrist Hospital Srinagar.
- 9. SSP Drug De-addiction Centre PCR Srinagar.
- 10. Deputy Controler, Drug controller Kashmir.

At the outset, Divisional Commissioner Kashmir welcomed the suggestions being put up by Civil Society Forum Kashmir for controlling Drug Abuse and discussed thoroughly the spread of menace of drug addiction among youth with line departments/NGOs/Civil Society members. He asserted that measures need to be taken to nip the menace & likewise menaces in the society.

The Divisional Commissioner Kashmir informed that Government is already taking measuring for drug de-addiction. In this connection, the Drug Controller Organization has suspended 148 licenses which were found guilty in selling allied narcotic drugs. The chair however, stressed that more and more prosecutions be put on fore in order to eradicate the menace from society.

After threadbare discussions, the following decisions were taken:-

S.No	Decision taken	Action to be taken by
1	Drug controller Organization, Kashmir shall publish the list of suspended licenses in leading daily newspapers and provide such list to all SHO's through respective SSP's. Controller, Drug and Food Safety Organization was directed to check medical shops to stop sale of alcoholic / drug ingredient medicines for eradication of this menace. Otherwise, strict action will be taken against defaulters and even can lead to cancellation of licenses.	Drug controller Kashmir. SSP's concerned.
2	DC's/Health Department/Drug Control Organization/NGO's will chalk out programmes/workshops against drug addiction to be organized at various forums to bring awareness about bad affects of this menace in the society particularly among youths. The plan for awareness programmes shall be framed at least for three months. Education Department will also initiate awareness programmes/non-formal educational camps in the Educational Institutions so as to train teacher fraternity to provide counseling / information about bad affects of menace among students. Deputy Commissioners will chalk out and conduct programmes and seminars within their respective districts regarding the subject and will fix prize distribution at District level. Finally a seminar at divisional level shall be held with proposed prize distribution for contestants amounting to rupees one lac for 1st prize, fifty thousand for second prize and twenty five thousand for the third prize respectively. 3	A committee has been formulated under the chairmanship of Principal Government Medical College Srinagar including representative of Deputy Commissioner Srinagar/ DIG-CKR/Director Education/Drug controller/civil Society to monitor the programmes/workshops against drug addiction. The HOD's may nominate dedicated nodal officers for the committee. The Committee shall be constituted within ten days and Principal Government Medical College Srinagar will issue	Dean, GMC/ Deputy Commissioner Srinagar/ DIG-CKR/Director Education/Drug controller/civil Society

	necessary orders for formation of the Committee. Principal Government Medical College Srinagar will take its first meeting sooner it's constitution. It's working shall be monitored and it's progress shall be documented. There shall be a Divisional level review after every three months.	
4	Police authorities were instructed to identify the Places /spots / spaces used for consuming the drugs which may be identified and sanitized. They will also involve volunteers from Red Cross/Home Guards who shall work in close coordination with the committee constituted for the purpose.	IGP Kashmir. 5	All Deputy Commissioners were instructed to organize various awareness camps against drug addiction. They are directed to involve the prominent citizens/Imams of local mosques to speak about the issue particularly on Friday sermons and other religious congregations.	A STATE OF THE PARTY OF THE PAR
6	Director SKIMS shall submit a detailed project report for establishment of modernized drug De-Addition Centre on modernized basis within one week.	Director SKIMS.
7	All Deputy Commissioners/District SSPS 'will mobilize NGOs working against social evils including respectable persons to spread message about bad affects of drug addiction. Besides, any case of drug addiction in a particular area /locality; be informed to police authorities.	
8	Mission Director, NHM have been instructed to arrange Psychologists /Counselors to organize counseling camps across Kashmir Division in order to curb drug addicts.	Mission Dir. NHM
