Subject:- Review meeting regarding the winter stocking in Gurez and snow bound areas of Kupwara.

A review meeting held under the chairmanship of Divisional Commissioner Kashmir on 30/09/2016 at 11.30 AM in connection with dumping of winter stocking in Gurez area of District Bandipora and snow bound areas of District Kupwara.

The Officers participated in the meeting are appended as **Annexure-A**.

At the outset, the Divisional Commissioner got feedback from participants regarding winter stocking of essential commodities viz, rice, atta, LPG, K. Oil, etc in snow bound areas of district Kupwara and Gurez area of District Bandipora.

Deputy Commissioner, Bandipora /Dy. Director (Supplies) FCS & CA, Kashmir informed the chair about the position of essential supplies to be dumped in Gurez Bandipora is as under:-

Deputy Commissioner, Kupwara /Dy. Director (Supplies) FCS & CA, Kmr informed that out of 61660 Qtls of Rice 49900 Qtls have been dispatched ,ie, 81% have been completed. However, for the Machil, Keran, Budnamal, Jumagund & Kumkadi 100% winter dumping of rice and 60% of Atta has been completed. 72% rice and 30% of Atta have been dumped in Karnah. The dumping of K.Oil in these areas of Kupwara is in progress and out of 96KLs, 48 Kls (ie, 50%) have been dispatched and

remaining quantity will be dispatched by 15th of October 2019. It was further apprised that the LPG cylinders in these snow bound areas is being dumped as under:-

The lifting of normal quantity of rice for the month of October 2019 is in progress and 30500 Qtls have been already lifted out of released quantity of 37746 Qtls, ie, 49% and the remaining quantity of rice will be lifted in a week.

Divisional Manager, FCI informed that there are sufficient stocks of rice available in the Kashmir Valley. The General Manager, SRTC also informed that sufficient number of trucks have been made available for transportation of food grains.

After threadbare discussions, the following decisions were taken

S. No.	Decision taken	Action by
1.	The remaining quantity of rice 2232 Qtls of under MMSFES /atta 2893.09 Qtls /LPG 300 cylinders/K.oil 44000 Ltrs. shall be dumped in the earmarked locations at Gurez within 05 days . The Deputy Commissioner shall report about the dumping of the essential supplies within 06 days time after proper verification.	DC Bandipora/ MD.SRTC/ Dir.FCS&CA/ GM FCI/ IOCL
2.	The remaining quantity of 40% atta for Machil, Keran, Budnamal, Jumagund & Kumkadi and 28% of Rice/72 % of Atta for Karnah shall be dumped in the earmarked location within 05 days. The remaining dumping of 48 Kls(50%) K.Oil shall also be made in 05 days in the snow bound areas of Kupwara. The remaining 9500 cylinders in Karnah, 1100 in Machil and 1200 shall be dumped in five days. The Deputy Commissioner shall report about the dumping of all these essential supplies to this office after proper verification.	DC. Kup/ Dir.FCS&CA/ MD.SRTC/ GM. FCI/ IOCL
