Subject:- District level Meeting on various issues.

A review meeting under the chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir was held on 26.09.2019 at 11.00 AM at Deputy Commissioner Office Pulwama regarding the review on developmental schemes/issues of all sectors.

Deputy Commissioner Pulwama along with all the District Level officers participated in the meeting.

The meeting focused on the following points.

- i. Status of opening /Operation of accounts of Panches/Sarpanches.
- ii. Holding of Gram Sabhas.
- iii. Monitoring of various programmes under languishing projects.
- iv. Position of essential supplies.
- v. Functioning of Schools/hospitals/offices.
- vi. Model village in tribal areas.
- vii. Mapping out of details of Land Bank State/Kacharai to be utilized for various projects especially for Industrial ventures and Industrial estates.

At the outset the chair sought feedback on above points and accordingly discussed with the officers of Departments/agencies viz, Education, Health, PHE/PDD /R&B,RDD,CA&PD, IOC, HPCL, SICOP, Social Welfare, Horticulture, Agriculture, Fisheries etc and issued necessary directions to the concerned officers for smooth functioning and early completion of the works in a time bound manner. The works on the languishing projects shall be completed/resumed immediately after exploring the possibilities of engaging the local labour. Besides, the officers should reach out to the public/ villages, listen their grievances and utilize resources to mitigate their problems. All the officers/officials shall ensure their availability to the public and shall live up to their aspirations.

The Deputy Commissioner, Pulwama apprised the chair that from the post 5th August 2019 period 3000 curfew passes were issued to employees, patients and other essential service providers especially to milk suppliers and chemist. 05 Satellite

phones were pressed into service at Pulwma, Awantipora and Tral. Besides Landline phones were activated for the benefit of public. The Internet kiosks were established at DC office and 10 computers were put into the services of general public /various departments for transactions on BEAMS/MGNREGA & Budgeting. A separate computer facilitation centre with 05 computers was dedicated to the students for online submission of forms/other educational related activities. Transport services were arranged for the students enabling them to reach the examination centers in their approved location. Immediate relief was provided to the victims of cloud burst at Wuyam, Khrew and Dood Marg in the mid August. One Nodal Officer was deployed at airport for facilitation / transportation of Hajjis to their homes for which 684 passes were issued to the kins of the Hajjis. 24x7 control room was established at District Administrative complex and 27 officers were deployed on magisterial duty for smooth functioning of public delivery system. All the necessary arrangements were put in place by the Health Department/PHE/PDD/Food /SFC etc during Muharram days in the villages of Gangoo, Haji Khello, Wakerwan, Hathkul and Panner Jagir. Swachta Hi Seva Abhiyan has been launched to make the district polythene free for which various darbars/camps were held at various establishments in order to emphasis on single use of plastic. A facilitation centre has been established for fruit growers under Market Intervention Scheme by NAFED at District Head Quarters. Instructions were given with regard to National Horticulture Mission/PM Kissan have been implemented. Two camps were held in which 61 farmers participated. The data has been uploaded through a private company which has not been fully paid till this time due to lack of funds. The law and order situation in the whole district remained by and large under control. The phone service was provided to general public after 10th of August at District HQ/Tehsil HQ/DPO/DPL and all police stations in which 30521 calls were made in addition to the 16478 calls made at DC Office.

The Deputy Commissioner further informed that all the Hospitals of the district including the Distt. Hospital Pulwama remain fully functional in which all the Lab investigations, diagnosis surgeries, procedures, Dialysis etc were conducted. There is no shortage of essential medicines/drugs in the hospitals of the district. Besides, medical camps were conducted at the villages of Satpukran, Mandakpal, Gujer Basti Lassipora, Wasoomarg and Aripal Tral. A state-of-art CT Scan plant has been installed at District Hospital and DNB courses has been started in the three specialties of Gynae & Obg., Surgery and Anesthesia. The engineering works of PHE/R&B/PDD to be carried out at the identified site of AIIMS Awantipora could not be started due to the non issuance of sight plan by the CPWD. However, the works on the four lanning of approach road is in progress. In the PM Jan Arogya Yojana (National Health Protection Scheme) out of targeted 74000 beneficiaries 51500 have been registered and the cards have been issued to 40000 beneficiaries. The district has been appreciated for the commendable work done in the Ayoushman Bharat programme in

which weaker sections of the society have been targeted. The Government of India, Ministry of Health & Med. Education endorsed our work by a special invite in a conference to be organized at New Delhi in which Hon'ble Prime Minister and Honb'le Health Minister will also be present.

There is no shortage of essential commodities/ supplies in the district. 58597 Qtls of rice has been distributed out of the 70303 Qtls of rice lifted for the months of Aug-Sept 2019. The winter stocking of essential supplies to all the 43 snow bound centers shall be made from the 1st of October which shall be completed in one week.

With regard to the Block Development Council elections, the electoral rolls has been published for all 11 blocks in which 132 panches/sarpanches has to perform as electors. 22 sarpanches are presently available, 04 seats have been kept reserved for women. Besides, 25 administrative officers have to perform in 168 panchayats. The processes of opening of joint accounts of sarpanches have been completed. The proposals of model village/digital villages have been submitted to higher authorities. The public outreach programs/camps were conducted. 35905 applications were received out of which all the applications were disposed off.

All the schools are functional in the district and 100% students of the class 10th, 11th & 12th have submitted the examination forms and attendance of staff remained 81.81 percent.

All the banks / ATM are normally operational in the district and an amount of Rs. 46.00 crores of cash has been drawn after 5th of August 2019. The Animal Husbandry and Fisheries departments are functioning normally. Rs.1.00 Lacs of revenue has been generated by the fisheries department.

A Solid Waste Management Plant consisting of 325 kanals of land has been identified at Malangpora. In order to decongest the traffic in the Pulwama town ,the Macdamization of New Bus Stand at Drussu amounting to Rs. 4.10 crores stands sanctioned. A professional College/Engineering College for which land of 400 kanal is available has been recommended for its approval, besides one Womens degree for Kakapora and one Degree college for Tral has been recommended for approval of higher authorities. The construction of Drug Store at CMOs office Pulwama has been approved.

As per the directions of the Chief Secretary and Divisional Commissioner, Kashmir, majority of the works of the languishing projects have been completed and the remaining works shall be taken up very soon. In total 104 projects were approved under languishing projects for following departments:-

The chair appreciated the efforts being put in place by the Deputy Commissioner Pulwama after the 5th of August 2019 and thereafter visited the District Hospital Pulwama and inaugurated Eco/Doppler lab and Dialysis Lab.

After the threadbare discussion with the Deputy Commissioner and his team of officers on the point wise agenda, following decisions/instruction were passed:-

- The chair directed that 100% attendance of employees be ensured in the offices/schools/hospitals and the action against the absentees without bonafide reasons shall be initiated immediately. The report in this regard shall be submitted to DC for onward transmission to Divisional Commissioner.
- The works regard operating/opening of joint accounts sarpanches shall be completed within a week. A joint inspection by the teams of police, revenue and allied departments in respect of basic amenities available in the building identified for the election of Block Dev. Council shall be carried within a week. The voters (Panches/Sarpanchs) shall be given to-and-fro escort and transport facility.
- The works under MGNREGA shall be resumed within one week.
- The officers should reach out to the public/ villages, listen their grievances and utilize resources to mitigate their problems. The community participation viz, traders, employees, volunteers etc shall be involved in plastic free campaign to sensitize the general public and

explore possibilities of providing jute/paper bags to the traders as an alternative to reduce the incidence of plastic use. The cleanliness /plastic free drive shall be also started to banks of rivers and other streams. The teams in this regard shall be constituted.

- The awareness/facility about pre-matric/post-matric scholarship schemes/ ISS Schemes etc shall be provided to the public. The officers of the Social Welfare department shall visit/reach to the villages/areas for the purpose.
- The work with regard to mapping out of details of land bank state/kacharai shall be completed in 07 days so that it can be utilized for establishment of various projects/schemes viz, industrial estates, play fields, schools, colleges etc.
- The works to be executed on the back to village programme feedback shall be immediately put to estimation and shall be started in another ten days. A report in this regard shall be submitted to Divisional Commissioner's office through DC office.
- All the departments viz, R&B/PHE/PDD shall explore the possibility of starting works and report in this regard shall be submitted accordingly.
- A time line with regard to completion of languishing projects shall be drawn and shall be intensively monitored by the Deputy Commissioner and in this regard inter departmental teams shall be constituted. In case there is dearth of skilled labourers, same shall be intimated and Divisional Administration shall explore the possibilities of arranging the skilled labourers from outside state for which they shall be provided camp site accommodation on the pattern of Bandipora/Kupwara.
- The youth engagement programmes viz, organizing sports tournaments, awareness camps with regard to drug menace/schemes of social welfare/NABARD/ etc shall be conducted at the tehsil/block/panchayat level.
- The chair further directed that the PDD officials /officers shall reach out to the public and detailed report shall be submitted with regard to deficiency/need of transformers or any other issue in order to meet out the crises especially in winter season.
- The action plan for celebration of Sharmdham on 2nd October 2019 shall be drawn and submitted within two days.



- The DPR of all the model /digital villages shall be submitted within one week.
- The professional college shall be allotted to the District Pulwama at the site approved by the Deputy Commissioner.

The meeting ended with a vote of thanks to and from the Chair.
