Subject: Record note of the meeting held under the Chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir on 29.12.2017 regarding providing/augmenting of mobile network service in Tulail & Gurez areas of Bandipora District.

A meeting under the Chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir was convened on 29.12.2017 regarding providing/augmenting of mobile network service in Tulail & Gurez areas of Bandipora District.

The following officers participated in the meeting:-

1. Deputy Commissioner, Bandipora along with Sub-Divisional Magistrate, Gurez (through VC)
2. General Manager, BSNL, Kashmir.
3. Chief Area Manager, Aircel/Vodafone/Jio/Idea.

At the outset, the Divisional Commissioner Kashmir informed the participants that the Hon'ble Chief Minister, J&K is concerned about the issues being faced by the people of Gurez and Tulail areas on account of poor mobile connectivity and impressed upon them to make efforts to strengthen the mobile connectivity in these areas.

Deputy Commissioner, Bandipora apprised the Chair that poor mobile network connectivity in Gurez and Tulail areas is due to the fact that the existing Mobile towers are not able to cover a distance beyond ½ kilometer. Further, he apprised the Chair that there is scope for improving the mobile connectivity by way of erecting additional towers at 17 locations.

After threadbare discussions, the following decisions were taken:-

1. All concerned Telecom Companies/service providers shall make efforts to strengthen the mobile network connectivity in Gurez/ Tulail so that the grievances of the public are redressed.

2. In order to resolve the issues impeding the Telecom Companies in strengthening/augmenting their connectivity in Gurez and other areas of District Bandipora, Deputy Commissioner,



