Subject:- Arrangements (security as well civil) for the forthcoming Shri Amarnath Ji Yatra 2021.

Divisional Commissioner Kashmir , took a meeting on 03.02.2021 in the meeting hall of this office regarding the issues which have been highlighted by the Security Forces at various designated Yatri Camps for the smooth functioning of Amarnath Ji Yatra.

The list of officers (civil/police/security forces) who participated in the meeting personally/through VC is enclosed as Annexure A"

At the outset CRPF presented a Power Point Presentation before the Divisional Commissioner, Kashmir about the Camp wise issues being faced by the pilgrims, service providers, administration as well by the Security forces during the Yatra for its smooth functioning. The chair impressed upon all the participants to gear-up immediately for the forthcoming Yatra and all the paper work shall be completed well before the start of executing of working season. Besides, possibility shall be explored to construct permanent facilities for the Yatra. The chair further, impressed upon all that the Covid-19 related SOP/Guidelines shall be adhered in letter and spirit.

After threadbare discussion and deliberations following directions were passed:-

1. Basic Requirements of all the Yatra Camps from Zig to Holy Cave viz. both the Axis of Pahalgam Baltal. The Chair impressed upon all the line departments that all the basic requirements/facilities viz. drinking water, electricity, separate washrooms/toilet, drainage, telecommunication services, Public Address System, high mast lights, gensets etc shall be made available to all the Yatri Camps of Kashmir Division well before the commencement of Yatra 2021 and any sort of failure by any agency/department shall be dealt strictly.
