Subject: - Minutes of the meeting regarding students Exchange programme from 8th April to 15th April 2018.

The Project Director informed the chair that about 508 students are arriving in two groups on 8th and 9th April 2018 by Air. Group "A" consists of 311 students and Group "B" consists of 197 students who are arriving on 8th & 9th April 2018 by Air respectively through 32 flights from 06. 55 AM to 4.00 PM and will return to Delhi on 14th

& 15th April 2018. These students will be staying at Teachers Bhawan Bemina, Hajj House Bemina, Hotel Abdullah Resorts and Hotel Grand Jhelum Rajbagh The students have to visit Gulmarg on 9th and 14th respectively. Students will also visit Mughal gardens, Tulip garden and "Run for Fun" from Peerzu park to SKICC and will also visit various schools in the city on 11th April 2018. They have to undertake various activities at Indoor Sports stadium, Srinagar on 12th April and Valedictory function is scheduled on 13th April at Indoor Sports stadium, Srinagar.

After giving details about the whole programme, following decisions were taken:

 All the concerned departments will nominate a nodal officer for the programme who will have to make close liaison with state Project Director RMSA J & K whose contact No. is 9469028888.
