MINUTES OF REVIEW MEETING REGARDING VARIOUS DEVELOPMENTAL PROJECTS OF SRINAGAR CITY INCLUDING SHEHR-E-KHAAS (DOWN TOWN).

A meeting was held under the chairmanship of Divisional Commissioner, Kashmir on 05.11.2018 at 04. 00 PM in the Meeting hall of this office to review various developmental projects of Srinagar city including the works underway in Shehr-e-Khaas (Down Town).

At beginning, the chair stressed that the Hon'ble Governor's Administration is keen enough in completion of the works of developmental projects in Srinagar. He added that firm decisions need to be taken & implemented on ground so that these projects do not go languishing.



The chair sought feedback from participants particularly from the Deputy Commissioner Srinagar who highlighted some significant issues faced by the district.

The critical issues that the Deputy Commissioner raised include the Traffic congestion, infrastructure gaps in education, Health & Power infrastructure. The Deputy Commissioner also emphasized on the lenient execution of works by line department viz-a-viz, sanitation by line department like SMC, enforced market checking by Legal Metrology, installation of lights on boulevard by PDD, drainage network and water logging by SMC/UEED etc.

The Deputy Commissioner asserted that the welfare schemes like Marriage Assistance & other schemes under ISSS & NSAP etc are vital for the poor and the people of Srinagar are mainly deprived because the number of marriageable girls in the district is very high in number. He requested the chair that the quota of funds for the District in such schemes especially the Marriage Assistance Scheme should be enhanced so that the poor get benefited.

The Deputy Commissioner also put up the details of major projects underway in Srinagar like expansion of Astaan of Dastgeer Sahab & Naqshband Saahab, Zaina Kadal, widening of SMS road, establishment of F&ES Station at Mahraj Gunj, expansion of Bone & Joint Hospital/CD hospital/JLNM hospital, construction of community halls, drug de-addiction, youth engagements & other acquisition cases. He asserted that the projects shouldn't be lurched for the want of funds & requested the chair for release of funds for timely completion of projects.

The Divisional Commissioner assured full support and directed line departments to expedite the works in a speedy manner so that the developmental works are completed in a stipulated timeline. Accordingly, the following decisions have been passed:





1. Deputy Commissioner Srinagar will review the status of pending projects viz-a-viz, expansion of expansion of Astaan of Dastgeer Sahab & Naqshband Saahab, Zaina Kadal, and expansion of SMS road with executing agencies. Collectors not in position, matters of acquisition; pending wherever together with issues regarding Government School Kalashpora shall be put up for HLC. A report to this effect shall be submitted in a week's time so that matter is taken up with Government, wherever financial implications are involved or appointment of particular Collector is concerned.

(Action to be taken by: DC Srinagar)

2. Under the preservation of ancient monuments and artistic interest, a report shall be submitted viz-a-viz the Budshah Tomb, Zaina Kadal within a week's time.

(Action to be taken by: Superintending Archaeologist, Archaeological Survey of India, Srinagar Circle).

3. Pursuant to the road widening of Syed Meerak Shah Road, DIG BSF Kashmir shall be apprised that the bunker at SMS, Nowpora may be dismantled and a mobile banker be stationed.

(Action to be taken by: Office of Divisional Commissioner, Kashmir.)

4. As far as establishment of Fire & Emergency Station at Mahraj Gunj Srinagar is concerned, the pending issues shall be taken with government in Housing & Urban Development Department.

(Action to be taken by: Office of Divisional Commissioner, Kashmir.)

5. For Central cemetery at Malkha, Deputy Commissioner Srinagar shall make a spot visit for possibility of rehabilitation of the residents at Rakhe-Arth so that after rehabilitation of residents, the central cemetery project can be implemented. Director Tourism shall submit a DPR to this effect.

(Action to be taken by: DC Srinagar/Director Tourism)

proper ensure Corporation shall Municipal arrangements and deployment of adequate staff in Srinagar. Besides; 6. Srinagar regular collection of garbage as early by ten in the morning on daily basis in each ward shall be ensured. Chief Engineer UEED shall submit a report about drains in low lying areas in Srinagar within it's jurisdiction. The report shall also encompass the reasons for inundation & plan of improving drainage structure by new projects/completion of ongoing drainage works.

(Action to be taken by: CE UEED/Commissioner SMC)

7. PDD will ensure that power is restored on top priority in the event of any eventuality. Since Chief Engineer PDD in the meeting asserted that the on boulevard disrupt power felling of twigs of poplar & other trees restoration during rain/snow/blizzard & other eventuality, it has been directed that pruning of any tree coming under the HT/LT alignment on boulevard shall be done in advance. Director Social Forestry shall submit regular reports to this effect.

(Action to be taken by: Director Social Forestry/CE: PDD)

8. A written demand shall be submitted by Director General Social Welfare, Kashmir for enhancement of fund quota under Marriage Assistance



Scheme for Srinagar District. A report shall also be submitted with regard to quantum of old age pension beneficiaries pending in the Division.

(Action to be taken by: Dir. General Social Welfare, Kmr).

9. Market checking squads and Food Safety department shall start intense market checking of chicken, mutton, bakery and other items. Strict action shall be taken against black marketers, hoarders and erring shopkeepers as per the law. Director General Health Services Kashmir shall constitute special checking teams to conduct daily inspection of all clinical establishments, diagnostic laboratories, and seal unauthorized clinics, diagnostic and quackery carts & those without licenses or being run by incompetent persons shall be taken to task as per law. Compliance report to this effect shall be communicated by Director General Health Services Kashmir.

(Action to be taken by: Director Health Service/Legal Metrology/Food Safety).

The meeting ended with a vote of thanks to the chair.
