A meeting under the Chairmanship of Mr. Baseer Ahmad Khan, IAS Divisional Commissioner, Kashmir was held on 29.11.2017 to sort out the issues impeding completion of work on four lanning of Parimpora-Narbal Highway road.

At the outset, the Divisional Commissioner, Kashmir welcomed the participants of the meeting and sought feedback from Officer Commanding, 53-RCC, Beacon on the progress of the work of four lanning of Parimpora-Narbal Highway road.

After having threadbare discussions, the following decisions, as indicated against each issue, were taken:-
