Subject: Minutes of the review Meeting held on 09-06-2018 regarding bottlenecks of various developmental issues of Down Town (Shehr-e-Khass) of Srinagar City.

A meeting was held under the Chairmanship of Divisional Commissioner, Kashmir on **09/06/2018** at **12. 00 Noon** to review the action taken report on the decisions taken in the meeting held on 29.05.2018.

The following officers participated in the meeting:-

- 1. Collector, KZP (Additional Deputy Commissioner) Srinagar.
- 2. Director, Fire & Emergency Services, Kashmir.
- 3. Superintending Engineer, PWD (R&B) Circle Srinagar/Circular Road Project Srinagar.
- 4. Joint Commissioner, Srinagar Municipal Corporation.

At the very start, Divisional Commissioner, Kashmir sought action taken reports from concerned departments pursuant to the decisions taken in the previous meeting on the subject. He also sought feedback from line departments with regard to modalities in acquiring land/structures & compensation being paid to the beneficiaries and reservations; if any.

Following decisions were taken on each point:-

 Old Zaina Kadal Brdige: Collector, Land Acquisition KZP will was earlier directed to visit on spot & report on structures coming under alignment of approach road of the bridge within 03 days. Same has not been submitted till date which shall be submitted to this office by 11<sup>th</sup> June 2018.

 Gadiyari: Collector KZP / SMC shall submit the action taken report with regard to dismantling of 04 numbers of structures that came under alignment; by11<sup>th</sup> June 2018.

3. Fire Service Station at Maharaj Gunj: Director, Fire & Emergency Services, Kashmir shall immediately submit DPR over the retrieved 05 marlas of land (encompassing therein the feasibility of the land) for establishment of Fire & Emergency unit at Maharaj Gunj. Report must



reach this office within 01 week so that the matter is taken up with the Government for accord and release of funds accordingly.

Community Hall at Kawadara: Since Commissioner, SMC has submitted 4. the proposal to this office matter shall be taken up with Commissioner/ Secretary, H&UDD for release of funds.

Namchibal Community Hall: Collector, KZP reported before the chair 5. that the work has already been started to initiate necessary action within 01 week. Collector, KZP has been directed to take up the matter of left out single beneficiary in next HLC.

- Community Hall at Fateh Kadal and Aziz Park Khanyar: Collector Land 6. acquisition informed that the chair that despite having been time to the beneficiaries. Yet they did not turn up. It was directed not to take action in the matter.
- Babademb: Collector Land acquisition Circular Road Project shall submit 7. a joint report together with Executive Engineer concerned as to whether the plots are available for the rehabilitation of the indenting/suffering families.
- Two Shopkeepers at Khanyar on KZP road: In order to facilitate the 8. rehabilitation of these shopkeepers, Collector Circular Road Project shall call the sufferers in the next meeting for disbursement of award.
