Subject:- Meeting regarding resumption of Train Services in Kashmir Valley.

Meeting held under the chairmanship of Divisional Commissioner Kashmir on 06/11/2019 at 11.30 AM regarding resumption of Train Services in Kashmir Valley.

The Officers participated in the meeting are appended as **Annexure-A**.

At the outset, the Divisional Commissioner, Kashmir got feedback from the concerned Deputy Commissioners/SSPs/ Northern Railway with regard to resumption of train services and impressed upon all to put in place the efforts for early starting of train services in Kashmir Valley for the convenience of people.

After threadbare discussions, the following decisions were taken:-

1. Chief Area Manager, Northern Railway, Kashmir shall ensure inspection/repair of railway track completed by or before 10th of November 2019.

(Action by: - Northern Railway)

2. SSP Railway shall make a detailed assessment of whole railway track and come up with the plan of any additional support from the respective Deputy Commissioners/SSPs and convey the same to them. DC/SPs shall accordingly take necessary steps to ensure hassle free train services. .

(SSP Railway/ Deputy Commissioners/SSPs)

3. Chief Area Manager, Northern Railway, Kashmir shall have be trial run conducted for Srinagar-Baramulla line on 11.11.2019.

(Action by: - Northern Railway)

4. After the above steps are taken Chief Area Manager (Railway) shall ply train from Srinagar to Bramulla (Twice a day to-and-fro) on 12th of November 2019 till further orders.

(Action by: - Northern Railway)

5. Chief Area Manager, Northern Railway, Kashmir shall conduct trial run of Srinagar-Banihal on 16th of November 2019. Train service from Srinagar-Banihal on 17th of November (twice to and fro) till further orders.


