Subject:- Meeting regarding Unauthorized occupation of proprietary land by 25 Corpus Battle School Khrew.

A Meeting held under the chairmanship of Divisional Commissioner Kashmir on 10/02/2020 at 3.00 PM regarding the subjected matter.

The Officers participated in the meeting are as under:-

1. Deputy Commissioner, Pulwama (through VC).
2. Principal, 15-Corpus Battle School, Khrew Tehsildar, Pampore.
3. Defence Estate officer, Circle Kashmir.
4. Tehsildar, Pampore.

At the outset the Divisional Commissioner, Kashmir sought feedback from all the participants regarding the said issue. The chair was apprised that proprietary land measuring 7 kanals and 2 Marlas (05 kanals 03 marls under survey No. 3394 & 2 Kanals & 2 Marlas under survey No. 3394) has unauthorizedly been fenced by 15 Corpus Battle School, Khrew. Dy. Commissioner Pulwama further apprized that land owners are approaching off and on for settlement of this issue and are requesting that the said land be either acquired or handed over back to them. Deputy Commissioner, Pulwama further raised two issues, viz. 1. Laying of underground pipeline through the garrison parallel to the already laid pipeline in order to augment water supply to the nearby area. 2. Realignment of 11 kv PDD line through 15-CBS Khrew. In response to this the Principal 15-Corps submitted that the said land was being used for parking without any authority and was a threat to security. In addition to above, Principal, 15 CBS requested that the revenue papers with regard to 133kanals and 10 Marlas of land have not been handed over to them by the Revenue Authorities. The Tehsildar Pampore informed that the revenue record of the said village is not in their possession but are in Central Records Room for scanning.

After thoughtful deliberations and threadbare discussions the following decisions were taken:-

1. Defence Estate Officer, Kashmir along with Tehsildar Pampore shall personally visit 15-CBS Khrew within one day and demarcate land belonging to land owners in presence of the Principal 15-CBS Khrew

and prepare revenue papers and send the request viz a viz acquisition of the said land to this office within seven days.

(Action by: - DC, Pul/DEO, Kmr/Tehsildar Pampore).

2. With regard to laying of underground PHE Pipeline , Deputy Commissioner, Pulwama shall send Executive Engineer, PHE to 15 CBS Khrew for resolving this issue on priority so that public will not suffer.

(Action by: - DC, Pul/ Prpl. 15 CBS /Xen PHE Pul).


3. With regard to laying of HT line, Deputy Commissioner, Pulwama shall send Executive Engineer, PDD to the site who shall discuss the issue threadbarely with the Principal 15-CBS Khrew in order to settle the issue.

(Action by: - DC, Pul/Xen PDD Pul/Tehsildar Pampore)

1. With regard to the land of 133.10 kanals, Tehsildar Pampore shall collect the papers from the Director Land Records /Central Record Room , Srinagar within two days and shall handover same to the Defence authorities on the next day.

(Action by: - Tehsildar Pampore)

The meeting ended with a vote of thanks to and from the Chair.
