Subject: Minutes of the meeting regarding problem of sewerage/drainage and bad road condition at Sonwar, Srinagar.

A meeting under the Chairmanship of Shri Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir was held on 10.08.2018 at 11.00 A.M. on the above mentioned subject.

At the outset, Divisional Commissioner, Kashmir welcomed the participants and informed them that the Hon'ble Governor have expressed his displeasure over the bad condition of road and sewerage/drainage problem at Sonwar, Srinagar.

Addl. Superintendent of Police, Traffic, Srinagar apprised the Chair that the traffic personnel face a lot of difficulties in traffic management from Pantha Chowk to Sonwar, more particularly near G.B. Pant Hospital, B.B. Cantt, Srinagar on account of bad condition of the road coupled with the slow pace of the work on the drainage undertaken by the U.E.E. Department.

Chief Executive Officer, B.B. Cantonment Board, Srinagar apprised the Chair that due to the recent repair works, the foundation of the high-mast light in front of G.B. Pant Hospital has weakened and requires immediate reinforcement/strengthening as there is apprehension of damage to the life and property.

After threadbare discussions on the below mentioned issues, the following decisions were taken:-

1. Bad Condition of road from Pantha Chowk to Sonwar:

Beacon will start the work on macadamization of road from Pantha Chowk to Sonwar by today evening and ensure its completion within 02 days.

(Action by: CE, BRO)

2. Ditches dug by PHE Department:

Chief Engineer, PHE, Kashmir will ensure that the work of replacement of old water pipeline by a new one is completed within 03 days.

(Action by: CE, PHE, Kmr)

3. Construction of drain by Cantonment Board:

The work on the construction of drain will be got expedited by Chief Engineer, UEED, Kashmir and ensure its completion within 03 days.

(Action by: CE, UEED, Kmr)

4. A team of the Officers from Revenue (DC Office, Srinagar), PHE, Traffic, Beacon and Cantonment Board will take an on-spot inspection of the area to identify the any other work which need to be taken up immediately.

(Action by: DC, Sgr/CE, PHE, Kmr/SSP, Traffic City/CEO, BB Cantt. Board)

5. Chief Engineer, PW (R&B) Department, Kashmir to undertake the work of reinforcement/strengthening of the foundation of the high-mast light in-front of G.B. Pant Hospital, Sonwar to avert any damage to life and property.

(Action by: CE, PWD, Kmr)

Deputy Commissioner, Srinagar will submit the compliance report of the above mentioned directions on 11.08.2018 at 11.00 A.M. The review of the above mentioned directions shall be taken on **11.08.2018 at 4.00 P.M.**
