- 5) The Chief Medical Officer, Srinagar shall make available First Aid facilities and also ensure availability of paramedical staff including physiotherapist at the time of inauguration of Geriatric centre at PHC Chanapora.

- 6) The J&K Housing Board will immediately install 04 CCTV cameras and installation of wooden racks after partition of the Pantry of Geriatric Centre at PHC Chanapora and also install electric water geyser.

- 7) The R&B Department shall make available dinner set / tea set / water purifier to Geriatric Centre at PHC Chanapora.
