The In-charge Divisional COVID Control Room, Kashmir briefed the Divisional Commissioner, about the functioning of Divisional Control Room, Kashmir besides apprising the Div. Com about various issues being faced by the Divisional Control Room and sought the intervention of the Divisional

Commissioner, Kashmir for their early resolution.

He insisted that all the patients should be visited by the Surveillance Teams of concerned districts on daily basis besides keeping track of the positive patients through regular phone calls and instant massaging of which an institutional memory should be made in both hard and digital formats. He passed instructions that all CMOs may be advised to build their own scientific mechanisms for making Home isolation effective and purposeful.
