Subject: - Minutes of meeting held under the Chairmanship of Divisional Commissioner, Kashmir on 09.04.2019 in connection with:

- I. Local issues about Khonmoh Industrial estate,
- II. Land identification for young entrepreneurs in District Srinagar, Budgam & Ganderbal and
- III. Craft clusters & Water transport within downtown.

A meeting under the Chairmanship of Baseer Ahmad Khan-IAS, the Divisional Commissioner, Kashmir was held on <u>09.04.2018</u> at <u>01.00 P.M.</u> to discuss various issues as supra.

At the outset, the chair sought concise description of demands/issues that are faced by various industrial unit holders. Among other issues, issue of Sewage Treatment Plant, Mobile connectivity & upkeep of lanes and drains at Industrial estate Khonmooh were put up.

Director, Industries and Commerce Kashmir informed that Identification of suitable Land Banks in District Srinagar, Budgam and Ganderbal for young entrepreneurs is imperative and that the already identified land at Rakh-e-Arth and Waskura is not suitable because it is marshy and will require lot of funds for development and also, it should serve the purpose for which it is to be utilized, which the chair accented to



After thoughtful deliberations and threadbare discussions, the following decisions were taken:-

Accordingly, Director Industries and Commerce shall inspect the site and submit its report within fifteen days after the work actually starts. 4.	Identification of a suitable land in District Srinagar, Budgam and Ganderbal for young entrepreneurs. The detailed report together with revenue extracts shall be furnished within two weeks. However, it should be kept in mind that the land so identified should be free from all encumbrances and should not be marshy.	Deputy Commissioner Srinagar, Budgam and Ganderbal
5.	bince nine ghats were previously thrown open for ublic/tourists, these ghats shall be rejuvenated or opether with embankments and also illuminated by a stalling heritage lights in consultation with Chief of Engineer I & FC. Also the bridges on river Jehlum of Dobji gath to Veer shall be illuminated by a stalling heritage light. The availability of pantoons hall also be ensured. To kick start the water ransport, the boats of the JKTDC shall be used as vater taxis for ferrying of tourists/locals. Private firms

	having boats shall also be approached/encouraged for the purpose. Installation of food courts at ghats/embankments shall also be explored in consultation with MD JKTDC & Director Tourism Kashmir.	
6.	Formulate a scheme for establishment of Craft Market in Downtown with scope/ guidelines and future course of action. Report shall be furnished within two weeks.	Director I & C, Kashmir/ Joint Director Handloom/Handicrafts, Kashmir/Representative of EDI
7.	Prepare a list of adequate craft traders with their specific line of activity/specific craft and also the locations of their craft. Besides those who are aspiring their venture in craft/Kashmir art.	Joint Director Handloom/Handicrafts, Kashmir/Representative of EDI

While concluding the meeting, the chair stressed upon these issues and indicated that this whole activity is convergence of different departmental activities to give boast to Water Transport and fillip to local craft.
