**Subject: Minutes of the meeting regarding issues of Railways.**

To discuss the issues pertaining to the Northern Railways as highlighted by the Chief Area Manager, Northern Railways in his communication dated 06.05.2019, a meeting was held under the Chairmanship of Shri Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir on 11.05.2019 at 12:30 P.M.

At the outset, the Chief Area Manager, Northern Railways, Kashmir gave a brief to the Chair about the issues/problems being faced on account of non-availability of various amenities at the Railway Colonies.

After threadbare discussions, the following decisions were taken:-

Providing/supply of clean drinking water to Railway Station & Railway Colony, Budgam	Chief Engineer, PHE, Kashmir will sent a team to the site for examining the quality of water and explore the possibility of providing potable water, in case the quality of water being provided to Railway Station/ Colony, Budgam at present is reported of poor quality. 3.	Providing/supply of clean drinking water to Railway Station, Pampore	Chief Engineer, PHE, Kashmir shall prepare estimates (DPR) for construction of additional water storage tank and will forward the same to the Chief Area	CE, PHE, Kashmir CAM, NR, Kmr

4.	Providing/supply of clean drinking water to Railway Station, Hillar and Qazigund	To assess the ground situation, Deputy Commissioner, Anantnag will send a team of Engineers/experts along with the Railway officials to the site who will submit the feasibility report regarding the issues	DC, Anantnag CAM, NR, Kmr
5.	Providing of electricity to Railway Station, Sadura through a dedicated feeder	CE, PDD, Kashmir apprised that a DPR for laying of underground cable conductors has been forwarded to CAM, Northern Railways, Kashmir for Accord of Approval and release of funds. CAM, Northern Railways, Kashmir will immediately release funds enabling Chief Engineer, Electric M&RE, Kashmir to get the work executed.	CAM, NR, Kmr
6.	Occupation of Railway Colonies/Barracks by Security Forces at Qazigund, Sadura, Punzgam, Kakapora and Pampore	Chief Area Manager, Northern Railways, Kashmir will furnish the details of the structures under the occupation of Security Forces to the respective Deputy Commissioners for placing it before the Rent Assessment Committee for finalization of rent/ payment of rent thereof. 7.	Construction of road at Railway Colony, Budgam	Chief Area Manager, Northern Railways, Kashmir intimated that funds have already been provided to the R&B Department for the said purpose, however, the road has not been constructed so far. Deputy Commissioner, Budgam will get the matter examined and issue necessary directions to the concerned in this behalf.	DC, Budgam CE, PW(R&B) Deptt., Kashmir Ex. Engg. R&B, Budgam
