2.	Chief Engineer, Systems & Operations, Kashmir will, within 07 days, submit a proposal for arrangements of funds for payment of compensation of land coming under towers.	CE, S&O, Kashmir
3.	Chief Engineer, Systems & Operations, Kashmir informed that the work on Lassipora Grid Station, Pulwama has started. Deputy Commissioner, Pulwama will visit the site and report, within 02 days, whether or not the work has started. Besides, he will report about the pace of the work.	
4.	Chief Engineer, Systems & Operations, Kashmir informed that the Project viz construction of Grid Station at Ahmadpora, Magam has been kept in the languishing projects and the work	



	will be started as soon as the funds are released. Chief Engineer, Systems & Operations, Kashmir shall pursue the matter with the concerned authorities for release of funds, so that the work on the Grid Station is started at the earliest.	
5.	Chief Engineer, Systems & Operations, Kashmir informed that the work on Chrar-i-Sharief Grid Station is going on in full swing and is nearing completion most probably by ending May, 2019. Similarly, Chief Engineer, Systems & Operations, Kashmir informed that the work on Alusteng Grid Station is going on in full swing. The Chair directed Chief Engineer, Systems & Operations, Kashmir to furnish progress report on fortnightly basis.	CE, S&O, Kashmir
