Minutes of the meeting regarding Market Checking.

In view of reports about the sale of essential commodities like vegetables, fruit, mutton, etc. on exorbitant rates, a meeting was held under the Chairmanship of Shri Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir on 11.05.2019.

Besides, Deputy Commissioner, Budgam/Pulwama/Shopian/Anantnag/ Kulgam/ Baramulla/ Kupwara/Bandipora/Ganderbal along with SSsP and Sectoral Officers participated in the meeting through VC.

At the outset, the Chair intimated the participants that there are large scale reports/complaints about the sale of essential commodities, especially vegetables, fruits, mutton, chicken, etc on exorbitant rates. The Chair further intimated that some unscrupulous business community is taking undue advantage of the recurrent road closure by hoarding the goods and creating scarcity, thereby indulging in profiteering/black marketing. The Chair stressed upon the participants to constitute interdepartmental market checking teams/Committees and ensure market checking on daily basis till last day of Ramadhan, so that no free hand is given to the shopkeepers indulging in profiteering/ black marketing. The Chair further stressed upon them to remain extra careful, especially in view of the Holy Month of Ramadhan, in mitigating the problems of the general public particularly on account of availability of essential

commodities. The Chair impressed upon the participants that strict action should be taken against the hoarders/black marketers so that it could be prove as a deterrent.

Thereafter, the Chair sought feedback from the respective Deputy Commissioners of Kashmir Division.

Deputy Commissioners apprised the Chair that the massive market checking drives have been started well before the start of the Holy Month of Ramadhan and shared the below details about market checking and fine imposed on the erring shopkeepers thereof.

Deputy Commissioners assured that the drives will be intensified and conducted till the Holy month of Ramadhan is over. Deputy Commissioner, Pulwama and Bandipora informed that shops, 10 in each district, who were found indulging in profiteering, were sealed by the market checking squads. It was also apprised that districts are not facing any shortage of essential commodities; however, the Deputy Commissioners raised a common issue about the non-availability of Sugar.

Deputy Commissioners of South Kashmir Range pointed out that the Petroleum products especially MS (Petrol) will last for 2-3 days in case the supplies are not restored/replenished. Similarly, Deputy Commissioner, Pulwama/Budgam/Kulgam/Shopian/Baramulla/Bandipora pointed out that frequent disruption in electricity is witnessed especially during Sehri and Iftari times.

Deputy Commissioner, Bandipora pointed out that the construction work on the Grid Station at Bandipora/ erection of transmission towers and laying of

transmission lines from Ganderbal to Bandipora, which will feed the grid station, is going at a slow pace. Besides, the Deputy Commissioner intimated that funds for payment of compensation to the land owners, whose land has been acquired for construction of towers, have not been yet placed with the Collector for disbursement.

Deputy Commissioner, Kupwara apprised that there is a huge demand from the people of Tangdar for allotment of Atta, however, Director, Food, CS&CA intimated that 06 truckloads of Atta, from the overall saving in District Pulwama, have been dispatched to Tangdar. Director, Food, CS&CA Department, Kashmir further intimated that around 4000 quintals of Sugar are available with the Department, however, instructions have not been issued by the Administrative Department with regard to its allocation to the Districts. He further intimated that pre-emptive measures have been taken for allocation of Atta to the Districts wherefrom the demand is received so that the demand of the people is met.

Chief Engineer, EM&RE, Kashmir apprised that the Chair that disruption in the electricity, as reported by the Deputy Commissioners, is because of overcharging of Lassipora Grid Station, Pulwama and Ahmadpora Grid Station at Magam, Budgam and their augmentation is going on, however, the issue with regard to disruption in electric supply at Sehri and Iftari times will looked into for early redressal, so that the general public does not face any inconvenience.

Commissioner, Srinagar Municipal Corporation, Srinagar apprised the Chair that sanitation drives are being conducted continuously for maintaining proper hygiene and to prevent spread of diseases. Besides, he pointed out that the Corporation is facing shortage of manpower, especially linemen which is badly affecting in the installation/repairs of streetlights. Further, Director, Urban Local Bodies, Kashmir informed that sanitation drives are being carried out in all towns, especially around Shrines and Jamia Masjids.

After threadbare discussions, the following decisions were taken:-

11.	Director, Sheep Husbandry/Animal Husbandry shall deploy teams at Lower Munda Toll Post for doing health audit of the livestock (sheep/goats/poultry birds), so that no unhealthy livestock enters the Valley for human consumption.	Dir., Sheep Husbandry, Kashmir Dir., Animal Husbandry, Kashmir
