Subject: SWACH BHARAT MISSION-----MINUTES OF THE MEETING REGARDING SWACH BHARAT DRIVE/SANITATION DRIVE.

A meeting was held under the chairmanship of Divisional Commissioner, Kashmir on 04.10.2018 at 11. 00 AM in the Meeting hall of this office, in order to finalize the modalities for Swach Bharat drive in & around the Summer Capital.

At the outset, the Divisional Commissioner Kashmir while reiterating the importance of cleanliness, assured that Swacchtaa is not the responsibility of only few people or groups but it is a collective social responsibility & öurged that the Swach Bharat drive should not be limited to the special drives/programmes but should be a round the year activity and the administration shall remain in full action for attaining the objectives of Swach Bharat Mission. He sought activity details of "Swachhta" drive from line departments.



The chair was informed by the Director Technical Education, J & K that the Department has undertaken various awareness programmes and sanitation drives in various localities, offices and outdoor locations.

Director Technical Education informed the chair that various activities have been undertaken in "Swachhta hi Seva" programme across the State like cleanliness drive, Swatchhta walk, educative awareness programmes, plantation drives, *Pad Yatra*, Cycle Yatra, awareness about Gandhi's teachings and other related activities in a phased manner.

Director Technical Education informed that the Department is capable of providing volunteer students from Polytechnic & ITI background for the Swach Bharat Drive.

The chair issued directives for immediate action to kick start the sanitation drives in the Srinagar city. He directed that focus shall be laid on in & around vicinities on river embankments of Jehlum & Dood Ganga. He also directed Srinagar Municipal Corporation to provide dedicated staff & equipments wherever required.

After threadbare discussions, following decisions have been passed:

October 2018 for which the Director Technical Education Department shall provide realistic Calendar. Focus shall be put on sides of Jhelum embankments from Zero Bridge to Amira Kadal on the first day followed by Amira Kadal to Habba Kadal, Doodganga Barzullah to Gangbug Bypass, SDA Bemina to Tengpora. The cleanliness drives shall proceed on 6th day towards Mughal Garden Pari Mahal to Chemashahi/Botanical Garden/Tulip garden and other gardens on proceeding dates. The drives shall be carried on at SRTC yards, Transport yard, Batmaloo, Parimpora and Patha Chowk. The last three days of the drive will be set up for awareness programmes which will be held in ten specified schools. The schools shall be identified by the Director Education Kashmir. The drive

will end on Children's Day i.e. 14th November 2018. The Deputy Commissioner Srinagar will monitor the drive and also provide magistracy support.

(Action to be taken by: DC Srinagar/ Director Technical Education/ Director Education).

2. Commissioner, Srinagar Municipal Corporation shall provide dedicated staff & equipment wherever required. Director Tourism shall provide every logistic support; as per the calendar formulated for the drive.

(Action to be taken by: Commissioner SMC VC SDA/ Director Tourism).

3. The Deputy Commissioner Srinagar shall take timely review of the status of sanitation drives and submit the reports to this office. He shall be responsible for impact analysis & shall suggest a suitable name for the drive (preferably a name in Kashmiri language). He shall also recommend suitable personality to be adjudged brand ambassador for the drive.

(Action to be taken by: Deputy Commissioner Srinagar).

The meeting ended with a vote of manks to the chair.
