Minutes of the meeting regarding contamination of Gilsar and Khushalsar.

Consequent upon the receipt of news item published in the daily Greater Kashmir dated 06.08.2018 from Raj Bhavan, J&K, a meeting was held under the Chairmanship of Shri Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir on 10.08.2018 at 3.00 P.M.

At the outset, Divisional Commissioner, Kashmir informed the participants that Hon'ble Governor, J&K has sought an immediate report of the news item published in the daily Greater Kashmir on 06.08.2018 under the caption "Gilsar water highly contaminated". As a sequel to this, a meeting has been convened to discuss the causes of contamination and remedial measures that could be taken to prevent further contamination and simultaneously improve the quality of water, which as per the report submitted by Chief Engineer, PHE, Kashmir is of poor quality and full of chemicals beyond permissible limits and very little oxygen.

After threadbare discussions, the following decisions were taken:-

4.	A week long special sanitation drive will be conducted by Srinagar Municipal Corporation around the two water bodies vis Gilsar and Khushalsar and ensure that these two water bodies are not used as dumping sites by the population residing around them.	Commissioner, SMC
