**Subject:** Flood Preparedness/Status of Land acquisition process of widening of flood channel and Construction of Bridge at Naidkhai, Bandipora.

A meeting was held under the chairmanship of Divisional Commissioner, Kashmir on 13/05/2020 regarding the subject cited above.

The following officer's participated in the meeting:-


- 1) Deputy Commissioner, Bandipora.

At the outset, Divisional Commissioner, Kashmir welcomed all the participants and while initiating discussions Collector I&FC informed that in total 80 Kanals of land has been acquired for the purpose of widening of flood channel at Gulabwari Naidkhai, out of which 100% payment has been disbursed against the 42 kanals and 50% disbursement against 38 Kanals of land. Besides, 6 kanals of land are under dispute among the landlords. He further, apprised that 5-6 structures are there who have raised apprehensions that while raising the bund up to 30 feet they shall face inconvenience The Chair was further apprised that the abutments/pier:2 of the bridge has been completed. Besides, the Pier cap casting and Girder fabrication is in progress .

**After threadbare discussion and deliberation following decisions were taken:-**

3.	The issue with regard to the shifting/acquiring of additional land of 4-5 families shall be decided after the personal visit of the site by the Divisional Commissioner Kashmir.	<b>DC Bandipora/ Collector I&amp;FC/ SDM</b>
4.	The deadline for the completion of the Naidkhai Bridge shall be strictly by or before <b>30.06.2020</b> . In case of any logical support/transportation of material etc Dy. Commissioner Bandipora and Divisional Commissioner, Kashmir shall be immediately informed for assistance. JKPCC shall chalk out weekly tabulated schedule work progress of the project at Nidkhai and shall submit to DC Bandipora and this office as well. DC Bandipora shall monitor the works and shall ensure its execution as per the chalk out schedule.	<b>CE JKPCC/I&amp;F C/DC Bandipora.</b>
5.	Chef Engineer, JKPCC shall submit the requisition with regard to labour, their movement from Budgam and any logical support to Deputy Commissioner, Bandipora for needful. Besides, the local labour from the red zone area of the district shall be allowed to work after conducting their Covid-19 test. All the works shall be shall be executed after following all the Covid-19 SOPs.	<b>CE, JKPCC/ I&amp;FC</b>
6.	Chief Engineer, I&FC shall ensure that the removal of obstruction material/debris if any, from the site by or before 30.06.2020. Besides, mobilization and widening process shall also start immediately.	<b>CE I&amp;FC</b>
7.	The chair assured that the matter with regard to the allotment of land in lieu of structures shall be followed with office of Principal Secretary, Revenue.	<b>ACC</b>
